Ruling #120

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER OR OWNER TO INSURE CONDITION OF HORSE), TRAINER SALVADOR OROZCO, WHO STARTED THE HORSE DANCING IN PARIS, THE FIRST PLACE FINISHER IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON MAY 2, 2021, IS FINED FIVE HUNDRED DOLLARS (\$500.00)* AND ASSESSED ONE HALF POINT (1/2) IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1843.4 (MULTIPLE MEDICATION VIOLATIONS) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (a, b, and d) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND #1843.1 (PROHIBITED DRUG SUBSTANCES-PHENYLBUTAZONE).

This ruling was written after a hearing on complaint # 21LA0070.

Ruling #121

JOCKEY ARMANDO VIRAMONTES IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1683 (MAXIMUM OVERWEIGHT) IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 11, 2021, RESULTING IN A LATE RIDER CHANGE.

This ruling was written after Mr. Viramontes failed to appear as requested.

(5) OBJECTIONS/INQUIRIES

Following the 5th race, the Stewards posted an Inquiry for interference after the start. Upon review, it was determined that the #2 horse Not Outtagas (jockey Diego Herrera) broke to the outside interfering with the #3 BDR Brave Heart (jockey Rodrigo Aceves), the #4 Iron Soul (jockey Oscar Peinado) and #5 Regalo Delosdoctores (jockey Juan Pablo Leon). #2 Not Outtagas finished 3rd and was placed 6th for the interference. Jockey Diego Herrera was found not to be at fault as he attempted to correct his mount.

Trainer Salvador Orozco was present for a hearing on complaint # 21LA0070 (Phenylbutazone).

(7) INCIDENTS

Following the 6th race, #4 Registrant (trainer Scott Willoughby) collapsed after he was untacked near the paddock entrance and was vanned off.
