PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER OR OWNER TO INSURE CONDITION OF HORSE), TRAINER ADRIANA VALLEJO, WHO STARTED THE HORSE ACCORDING TO PLAN, THE SECOND PLACE FINISHER IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON MAY 28, 2021, IS FINED FIVE HUNDRED DOLLARS (\$500.00)\* AND ASSESSED ONE HALF POINT (1/2) IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1843.4 (MULTIPLE MEDICATION VIOLATIONS) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (a, b, and d) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND #1843.1 (PROHIBITED DRUG SUBSTANCES-ISOFLUPREDONE).
