RODRIGUEZ RULING

HCFA RULING #01

Apprentice Jockey **Jose Elias Rodriguez** who rode "**ODESSA**" in the first race at Golden Gate Fields on Sunday, August 15, 2021, is suspended three (3) racing days August 27, 28 and 29, 2021; for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board Rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The above ruling was written after Mr. Rodriguez reviewed the race in question with the stewards and his interpreter. He understood that he let his horse drift in the stretch causing interference.

PENA RULING

HCFA RULING #02

Jockey **Brayan Pena** who rode "**TED**" in the eleventh race at Golden Gate Fields on Sunday, August 15, 2021, is suspended three (3) racing days August 27, 28 and 29, 2021; for altering course without sufficient clearance causing interference in the stretch resulting in the disqualification of his mount from third to last; a violation of California Horse Racing Board Rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The above ruling was issued after Mr. Pena appeared and reviewed the race with the stewards. He recognized that he made an error in judgement when he angled his mount out and interfered with numerous horses.

LATE SCRATCH 4TH RACE

#2 **SHANGHAI CURLY** flipped in the gate unseating Jockey Jose Rodriguez. Track Veterinarian Audrey Clifton recommended the horse be scratched and the stewards agreed. The refund totaled \$10,605.58.

The inquiry sign was posted to review the actions of #1 "**FOREIGN PROTOCOL**" (McKenzie King) in the final turn of this seven furlong event. #1 raced wide into the path of #'s 2, 3 and 6 eventually causing #6 to clip heels with #2. Jockey Luis Gonzalez managed to stay on #6 and pulled him up in the stretch. As a result of the interference #1 was placed unplaced since #6 did not finish. Jockey King was ordered to see the stewards tomorrow.

KING RULING

HCFA Ruling #3

Jockey **McKenzie King** who rode "**FOREIGN PROTOCOL**" in the sixth race at Humboldt County Fair on Saturday, August 21, 2021, is suspended three (3) racing days August 29 and September 3 & 4, 2021; for altering course without sufficient clearance causing interference in the far turn resulting in the disqualification of her

mount from second to unplaced; a violation of California Horse Racing Board Rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The above ruling was issued after Ms. King reviewed the race with the stewards along with trainer Quinn Howey. She understood that we expect a better effort to straighten a horse that is bearing out.

MAELFEYT RULING

HCFA Ruling #4

Trainer **Bruno Maelfeyt** is fined the sum of Three Hundred Dollars (\$300.00) for failure to have sufficient works on the horse "**LORD VADER**" necessitating a scratch in the fourth race on Saturday, August 21, 2021. A violation of California Horse Racing Board Rule #1581 (Racing Secretary to Establish Conditions - Workouts Required).

The above ruling was issued when Mr. Maelfeyt failed to work his horse 3/8 of a mile to be eligible to race.
