**FILM REVIEW**

Jockey UMBERTO RISPOLI was issued the following ruling after he accepted the penalty for violating the CHRB #1688 (riding crop) in yesterday's fifth race. Mr. Rispoli raised his hand above his shoulder when using the riding crop.

**LATC RULING #02**

Jockey UMBERTO RISPOLI, who rode VIAZAR in the fifth race at Santa Anita Park on October 8, 2021, is fined SEVEN HUNDRED and FIFTY DOLLARS (\$750.00)\* for violation of California Horse Racing Board rule #1688 (c)(2) (Use of Riding Crop – above the shoulder level – second offense in the last 60 days).

Apprentice Jockey JUAN ESPINOZA was in to review yesterday's first race. Mr. Espinoza was called in when his horse floated out slightly entering the stretch causing the two outside horses to shift out into the path of another horse. He stated he looked prior to moving out, and he didn't see the outside horse who was driving in between his horse and the outside horse. We agreed that another horse contributed to the incident, but we warned him that he has to do a better job in the future. We unanimously voted to issue him a warning.

Jockey ABEL CEDILLO was in our office to review the start of yesterday's ninth race where he made contact with the inside horse as they left the starting gate. Mr. Cedillo placed some of the blame on the inside horse, but he agreed he could of have performed better. We agreed that the inside horse had some of the blame, but he could have done a

better job maintaining a straight course out of the gate. We felt the incident wasn't penalty worthy and he was issued a warning.

**STEWARDS' INQUIRY/OBJECTION/DISQUALIFICATION**

We posted the inquiry sign after the running of the second race to review the stretch run involving the unofficial winner #2 CARELESS KITTEN (E. Maldonado) and the second-place horse #4 WARRENS CANDY MAN (J. Hernandez). Mr. Hernandez also lodged an objection against the #2 for interference. After speaking to the jockeys, patrol judges and reviewing the video, we disqualified the #2 and placed him second behind the #4. We unanimously voted that the #2 drifted out making contact with the #4 taking him off his path, costing him a better placing.
