Report of the Board of Stewards for the week of November 1, 2021, through November 7, 2021.

**Monday**

11/01/2021

**(1) HEARINGS**

On Monday, three hearings were conducted.

Hearing on Complaint #21LA0165, filed by Cesar De Alba against owner Craig Martin, for a training bill for the amount of \$1,627.50. After hearing testimony from both parties, the Stewards allowed a continuation for two weeks for Mr. De Alba to provide further information to Mr. Martin. Mr. Martin agreed if the information was provided, he would take care of the full amount owed.

Hearing on Complaint #21LA0150, filed by Post Time Self Insurance against Anthony Stabile, for the amount attributable to \$1,794.00. After hearing evidence from both parties, the Stewards were unable to determine if the amount owed was Anthony Stabile or the owner of the horses. Post Time Insurance was asked to provide the signed contract for the insurance. As of Saturday 11/06/2021, this information has not been provided.

Hearing on Complaint # 21LA0151, filed by Post Time Self Insurance against Reina Gonzalez, for the amount of \$1,381.36. At the time scheduled for the hearing, Reina Gonzales had not contacted the Stewards. Shortly after, Reina Gonzalez called and was placed in contact with Post Time Self Insurance to settle this amount.
