WEDNESDAY

06-20-18¹ **DUTY STEWARD**

Steward Will Meyers was present to supervise entries and declarations.

THURSDAY

06-21-18¹ **RULING #5**

Jockey **FRANCISCO MONROY** who rode **LET IT BE ME** in the first race at Oak Tree at Pleasanton on Sunday, June 17, 2018 is hereby fined the sum of One Hundred dollars (\$100)* for violation of California Horse Racing Board rule #1688 (use of Riding Crop – used more than three times without giving the horse a chance to respond).

The foregoing ruling was issued after Mr. Monroy appeared and admitted he violated the crop rule by striking his mount four consecutive times in the stretch.

06-21-18² **RULING #6**

Jockey **LUIS LIRA** is hereby fined the sum of One Hundred Dollars (\$100)* for failure to report his proper weight, necessitating a rider change in the first race at the Oak Tree at Pleasanton meeting on Sunday, June 17, 2018, a violation of California Horse Racing Board rule #1682 (Weighing out).

The above ruling was issued after Mr. Lira met with the Stewards and apologized for failing to make his assigned weight for the first race on Sunday, June 17, 2018.

06-21-18⁴ **STEWARDS REVIEW – 2nd RACE**

The Stewards conducted a review of the second race for the benefit of the wagering public. The video shows #2 ROSIE'S GOLD (Irving Orozco) duck into the rail near the 1/16 pole. Jockey Orozco was fortunate to hang on as he lost both irons. No other horses in the four horse field were involved.

06-21-18⁵ **STEWARDS REVIEW - 3rd RACE**

The Stewards showed a review of the start of the third race for the wagering public. The video shows #4 LIFE NO PAROLE (Irving Orozco) lifted and was off to a poor start. The gate opened properly and LIFE NO PAROLE was declared a starter.

06-21-18⁶ **CLAIM VOIDED – 5th RACE**

The Stewards voided the claim submitted by Trainer William E. Morey for the four year old filly SOUGHT MORE PEP after the Official Veterinarian Diane Isbell, DVM, reported the filly lame in the left foreleg. SOUGHT MORE PEP was returned to the Rene Amescua barn.

06-22-18¹ **RULING #7 – FRANK ALVARADO**

Jockey **FRANK ALVARADO** who rode **FRENCH TART** in the third race at Oak Tree at Pleasanton on Thursday, June 21, 2018 is fined the sum of Three Hundred Dollars (\$300)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop – on the head, flanks, or any parts of its body other than the shoulders or hind quarters).

The above ruling was issued after Mr. Alvarado met with the Stewards and explained his mount (#3 FRENCH TART) was trying to drift out when he tapped her a couple of times on the side of her head with the riding crop. He realizes that the crop may not be used on any part of the head and accepted the penalty imposed.

06-22-18² **RULING #8 – JOSE MANUEL RODRIGUEZ (18GG0003)**

Jockey Agent/Valet Jose Manuel Rodriguez, having now appeared and a hearing having been held, is restored to good standing and Pacific Racing Association ruling #119, dated June 3, 2018 suspending Mr. Rodriguez for violation of California Horse Racing rule #1547 (Failure to Appear) is hereby set aside.

Further, Jose Manuel Rodriguez, is fined the sum of Five Hundred Dollars (\$500)* for violation of California Horse Racing Board rules 1874 (Disorderly Conduct – Altercation) and 1481 (Occupational Licenses and Fees – working without proper license). Additionally, Jose Manuel Rodriguez, is placed on probation for the term of his license (11/2018).

The foregoing ruling was issued after Mr. Rodriguez waived counsel and a formal hearing to address an incident that took place near the paddock at Golden Gate Fields on January, 15, 2018. According to the complaint, "Agent Rodriguez instigated a verbal altercation with Trainer Anthony Stabile that resulted in a minor physical altercation. During the physical altercation Trainer Stabile was shoved and fell down a flight of stairs causing minor injury."

Mr. Rodriguez denied hitting or pushing Mr. Stabile causing him to fall back and down the stairs. However, the Track Veterinarian, Sara Sporer, DVM, witnessed the confrontation and aside from the loud and foul language used by Mr. Rodriguez, she clearly saw the latter "purposefully and with great force used both hands to shove Mr. Stabile in the chest,

causing him to fall backwards on the concrete stairs, breaking a lens out of his eyeglasses." Decision forthcoming.

06-23-18¹ **FILM REVIEW**

The Stewards met with Jockey Heribert Martinez for a review of his effort in the seventh race yesterday.

Mr. Martinez, who rode #6 MR. TWINERY, made a couple of questionable moves down the backside of this six furlong event. The veteran rider explained his mount was somewhat hard to handle and realized he bothered another horse. Fortunately, that other horse #3 MALIBU ALEX (Alejandro Gomez) went on to win the race.

Mr. Martinez was issued a stern warning about intentionally altering course and/or not making an effort to control a difficult horse.

06-23-18³ **OBJECTIONS – 1ST RACE**

Two jockey objections were lodged following the first race (Quarter horse).

Jockey Shawn Spikes, who rode #3 HIGH ON A SECRET (4th) claimed foul against #4 ZOOMIN FOR HIBUX (Jesus Velazquez) who finished third. The Stewards disallowed this Objection as Mr. Spikes mount broke out at the start and caused more interference than the slight inconvenience he suffered later on in the race.

The second objection by Jockey Jesus Velazquez, who rode #4 ZOOMIN FOR HIBUX (third) against #6 OUTDASHN (Luis Godoy) (first) was also disallowed as the Stewards determined the latter was clear while drifting in late in the race.

Both decisions were unanimous.

06-23-18⁴ **ACCIDENT – INQUIRY 2ND RACE**

The Stewards posted the inquiry sign following the second race (mule).

The video shows #3 PLEASE BELIEVE ME (Luis Godoy) bucked and unseated her rider midway through this 350 yard mule event. PLEASE BELIEVE ME will be placed on the Stewards List. Jockey Godoy was uninjured.

06-23-18⁵ **ACCIDENT – INQUIRY 9TH RACE**

The Stewards conducted an inquiry following the ninth race to review an accident at the start of this five and one half furlong event.

The video shows #4 LUCK LASTS (Frank Alvarado) broke in the air and unseated his rider. LUCK LASTS was declared a starter and Jockey Alvarado was not injured.

SUNDAY06-24-18¹ **RULING #9 – JESUS VELAZQUEZ**

Jockey **JESUS VELAZQUEZ** is hereby suspended pending an appearance before the Board of Stewards at Oak Tree at Pleasanton for failure to appear as ordered; a violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of **JESUS VELAZQUEZ** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The above ruling was issued as Mr. Velazquez failed to appear for a review of his use of the riding crop during the first race on Saturday June 23, 2018.
