Following the telephonic hearing, Jesus agreed to pay his former agent, David Kasparian, five hundred dollars (\$500.00) for services rendered. Mr. Velasquez argued that he should not have to pay his former agent at all.

It was explained to Mr. Velasquez that the time for arguing his case had passed and that a settlement had already been agreed upon. Reluctantly, the payment was submitted to the Stewards and the check will be sent to Mr. Kasparian.

6-28-13⁴**HEAT WAVE**

With triple digit temperatures forecasted, the Stewards called for a meeting with track personnel to address procedures concerning horses potentially suffering heat stroke. Present at the meeting were CEO Jerome Hoban, Asst. Director of Racing Jeanne Wasserman, Maintenance Manager Ed Johnson, Stable Superinten-

dent Jim Burns, CARF Chief Operating Officer Larry Swartzlander, and CHRB Official Veterinarian Dr. Dooley and Horse Ambulance Driver Cliff McDonald.

Various topics and scenarios were discussed. All involved agreed that having water available and easy to access was of the utmost importance. Ed Johnson helped solve that concern by placing hoses and buckets at four different spots around the race-track and on the bridle path. The meeting resulted with all involved being better prepared in handling any horse related heat issues.

6-28-13⁵**RULING NO. 08 – CARLOS LOPEZ-HERNANDEZ**

Groom **CARLOS LOPEZ-HERNANDEZ (AKA: CARLOS ALBERTO TIRADO-PAJARDO)** is hereby suspended pending an appearance before a Board of Stewards for failure to appear to answer charges of alleged violation of California Horse Racing Board rules #1481 (Occupational Licenses and Fees), #1890 (Possession of Contraband), #1489 (C) (H) (Grounds for Denial or Refusal of License), and #1874 (Disorderly Conduct); a violation of California Horse Racing Board rule #1547 (Failure to Appear).

The above ruling was issued after Mr. Pajardo failed to appear before the Stewards.

After opening the record all parties submitted their testimony and evidence. Upon completion of that the record was closed and submitted for decision.

RULING NO. 10 – TRAINER JEFF BONDE

Trainer **JEFF BONDE** is hereby fined one thousand dollars (\$1000.00)* for failure to properly report the gelding of the horse TAHOE FLASH which started in the seventh race on June 21, 2013 at the Alameda County Fair (Pleasanton); a

violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

The above ruling was issued after Mr. Bonde signed a waiver accepting responsibility.

GOMEZ HEARING

An informal hearing was held to address a financial complaint filed by Exercise Rider Fastino Garduno against Trainer Ruben Gomez for \$575.00. Mr. Gomez did not dispute the billing or the amount. Mr. Gomez asked for, and received some time to pay the bill. Mr. Gomez stated that he could pay the bill in full on Thursday, July 5th. A financial agreement was signed and hopefully this matter will be resolved.

FILM REVIEW

Jockey Louis Godoy watched replays of Saturday's second race with the Stewards. In that race Mr. Godoy's mount BAR JF EASY MONEY (3rd) was involved in an inquiry. BAR JF EASY MONEY ran erratic, in and out, from gate to wire. Every time Mr. Godoy tried to use his whip, left or right handed, his mount would shy away from it.

It was explained that obviously one can't hit this mule. It was advised that mounts like this one will get a rider in trouble if they do not "listen when a mount is telling you something." It was advised that Mr. Godoy not hit this mount and once he has straightened a mount and hits it on the same side again it is indefensible. He was warned that causing interference will get him days.

The tapes show #5 come out sharply into #6 RED ROOSTER who was knocked into #7 BABY SISTER Whose rider was close to being unseated. In a unanimous decision #5 JANI NELSON was disqualified from third and placed seventh (last).
