07-07-10 **ENTRY & SCRATCH DAY**

The stewards and racing offices were open today. The racing office compiled a good card for Saturday, July 10 with eleven (11) races scheduled. Scratch time for Friday, July 9 was held in the racing office this morning. Two (2) scratches and five (5) jockey changes were activated following the 9:00 a.m. deadline. Two (2) written trainer exams were administered in the racing office.

07-08-10¹ **CALVARIO CASE 09GG065 RE-OPENED** (Ref: 07-03-10²)

Senior special investigator Gabe Palomar presented a court order from the Superior Court of California, County of San Mateo. The pertinent part of the order which pertained to the California Horse Racing Board and Calvario's licensure reads as follows: "DCSS shall notify the Board that trainer's and groomer's licenses for respondent may be issued. DCSS shall withdraw its request to suspend respondent's licenses." Signed by Commissioner Kathleen McKenna. This new information was placed on the record and will be considered in our findings.

07-08-10² **OMAR RAKIM - CASE 10GG118**

Hot Walker **OMAR RAKIM** was cited for alleged violation of California Horse Racing Board rules 1489 (Grounds for Denial or Refusal of License) and 1509 (Use of License Required). An arrest by Berkeley Police and non-participation at a race meet were the issues. Rakim failed to appear. Action against his license will be forthcoming.

Friday07-09-10¹ **RAKIM RULING NO. 10** (Ref: 07-08-10²)

Hot Walker **OMAR RAKIM**, having failed to respond to written notice to appear before the Board of Stewards at the Alameda County Fair (Pleasanton) on or before Thursday, July 8, 2010, to answer charges of alleged violation of California Horse Racing Board rules #1489(h) (Grounds for Denial or Refusal of License) and #1509 (Use of License Required), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of OMAR RAKIM are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued following yesterday's scheduled hearing which Mr. Rakim failed to attend.

07-09-10² **CALVARIO CASE DISMISSED** (Ref: 07-08-10¹)

Case #09GG065 was dismissed this morning after discussion of yesterday's presented evidence. Basically it appeared Child Support Services were holding Mr. Calvario's feet to the fire for back child support by requesting this Board suspend (revoke) all California Horse Racing Board licenses in accordance with Family Law #17520. We held hearings and were headed in that direction when at yesterday's hearing, Child Support Services backed away from going after Mr. Calvario's licenses. Since horse racing may be his only means of support, the change may be warranted.

07-09-10³ **CIACCIO vs. GLEASON**

Owner **Ken Ciaccio** e-mailed the stewards' office concerning possible conflicts with his trainer Patrick Gleason. The stewards passed the e-mail on to investigator Barbara Chimera for follow up with Mr. Ciaccio.

07-09-10⁴ **FILM REVIEW**

Jockey **Luis Godoy** was in to review his ride aboard the mule BAR JF CN DOUBLE in Monday's second race. Godoy was a little late to straighten his mount and cautioned to make a quicker reaction when riding mules.

Saturday07-10-10¹ **RUBACALVA HEARING CASE 10GG114** (Ref: 06-27-10¹)

Attorney **Jim Ghidella** appeared on behalf of **Gilberto Rubacalva** today. Mr. Rubacalva's license has expired and he has not applied for a renewal. This Board of Stewards dismissed the case without prejudice to possibly be filed again at a later date when, and if, Mr. Rubalcava applies for a license.

Jockeys **Chad Schvaneveldt** and **David Lopez** were in and warned to make better efforts to straighten their mounts in traffic.

07-10-10³ **RULING NO. 11 – PICHES**

Trainer **JOHN PICHES**, who was scheduled to start PROUDD PRUF in the second race at the Alameda County Fair (Pleasanton) on Friday, July 9, 2010, is fined the sum of two hundred dollars (\$200.00) for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – late for lasix).

The above ruling was issued after it was determined that assistant trainer Morris Parker miscalculated the amount of time necessary to ship from Sacramento to Pleasanton causing PROUDD PRUF to miss its lasix treatment.

07-10-10⁴ **INQUIRY – DISQUALIFICATION – First Race**

The inquiry sign was posted to review possible interference involving third place finisher #4 DESERTS HOT TOUBLE (Juan Arriaga) and fifth place finisher #3 LA PLEBITA (Luis Lira). After review and talking with the riders, it was determined that #4 interfered with #3 at two different spots in this 350 yard Quarterhorse race. At the start #4 breaks in hitting the hind quarters of #3 causing that rival to lose momentum. #4 comes in again half way through the race forcing #3 to check behind eventual winner #2 JUST SNOW.

#4 was disqualified from third to fifth for the interference.

07-11-10⁴ **RULING NO. 12 – STANSFIELD**

Trainer **CHUCK STANSFIELD**, who was scheduled to start KNIGHT RAVEN in the seventh race at the Alameda County Fair (Pleasanton) on Saturday, July 10, 2010, is fined the sum of two hundred dollars (\$200.00) for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – improper medication).

The foregoing ruling was issued after Stansfield accepted responsibility for failing to register KNIGHT RAVEN as a bleeder.

07-11-10⁵ **INQUIRY – DISQUALIFICATION – First Race**

The inquiry sign was posted in this 350 yard Quarterhorse race to review possible interference involving third place finisher #5 CHECK THIS DREAM (Gregorio Arriaga) and fourth place finisher #3 BARRY SNOW MERRI (Rodrigo Maldonado). About half way through the race #5 comes down and bumps #3 and continues to force that rival off its path through the finish. #3 was beaten a head by #5 for third and in the unanimous opinion of the stewards cost a chance at a better placing. #5 was disqualified from third and placed fourth for the interference.
