The inquiry sign was posted against #3 “BEST DREAM SEEKER” second (2nd) place finisher for possible interference to #1 “RED STAR TIGER” sixth (6th) place finisher at the three-quarter pole. After film review the stewards unanimously decided no violation occurred, thus original order of finish stands.
