RULING # 17

TRAINER **MONA ROY** WHO STARTED THE HORSE **“YOU NAME IT”**, WHO FINISHED FIFTH IN THE NINTH RACE AT CAL EXPO ON JANUARY 19, 2018 IS FINED FIVE HUNDRED **(\$500.00)** DOLLARS* PURSUANT OF CALIFORNIA HORSE RACING BOARD RULE **#1887** (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE **#1843(d)** (MEDICATION, DRUGS, AND OTHER SUBSTANCES) AND **1843.1(b)** (ANY DRUG, SUBSTANCE, MEDICATION, OR CHEMICAL AUTHORIZED BY ARTICLE IN EXCESS OF THE AUTHORIZED LEVEL OR OTHER RESTRICTIONS AS SET FORTH IN THIS ARTICLE) MEDICATION – COBALT (CLASS 4C) IN EXCESS OF PERMITTED LEVEL (28.37 ng/ml) FIRST OFFENSE.

The race office was open today accepting entries for qualifying races to be conducted today at 5:30PM. The resultant qualifying sheet showed twelve (12) horses competing in two (2) qualifying races.

Two (2) qualifying races were conducted commencing at 5:30PM before the twelve (12) race pari-mutuel card of twelve (12) participants. Eight (8) were successful in their qualifying effort.

02/16/18 (4) **Sixth Race/ Inquiry**

Inquiry sign was posted on first place finisher #6 “STORMING D ODDS” Driver Lemoyne Svendsen for possible violation of CHRB Rule #1722 “Breaking Rule” after the quarter. After film review the Stewards unanimously decided that no interference occurred and the race made official.

The Inquiry sign was posted on the second place finisher #5 “WINDSUN T BIRD” with Driver Nick Roland for possible violation of the CHRB Rule #1722 “Breaking Rule” in the stretch. After film review the Stewards unanimously decided that #5 “WINDSUN T BIRD” did comply with the “Breaking Rule.” Order of finish stands.
