The inquiry sign was posted in order to review the actions of #5 “MISS BAJOLINA” the original fifth place finisher. At issue was the observation that #5 caused interference in the stretch to seventh place finisher #7 “TOTALLY RACY” Driver Steve Wiseman. After film review the Stewards unanimously concluded that #5 did cause the interference resulting in a disqualification. Ruling will be written.

#6 “STORMING D ODDS” Driver Lemoyne Svendsen finished fifth drove inside the pylons at the top of the stretch causing the horse to break stride. After film review, the Stewards unanimously decided that #6 was lapped on at the finish resulting in a placing.
