SECOND OFFENSE IN LAST SIXTY (60) DAYS.

RULING #15

TRAINER **GEORGE REIDER** WHO RACED THE HORSE “**FF BIGSHOW**” IN THE FIFTH RACE ON NOVEMBER 24, 2017 FINISHING FIRST. SUBSEQUENTLY, “**FF BIGSHOW**” WAS POST RACE TESTED ACCORDING TO CHRB PROTOCOLS RESULTING IN TEST **#CE27775**. SAID SAMPLE WAS SUBMITTED TO THE MADDY LABORATORY AT UNIVERSITY OF CALIFORNIA, DAVIS THE OFFICIAL TESTING LABORATORY FOR THE CHRB, FOR TESTING.

THE TEST RESULTS FROM SAMPLE **#CE27775** SHOWED THE PRESENCE OF **PHENYLBUTAZONE** AT A LEVEL OF 4.43 UG/ML IN EXCESS OF THE ALLOWABLE THRESHOLD OF 2.0 UG/ML. AS RESULT OF THIS TEST FINDING AND IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE **#1843.3** (MEDICATION, DRUGS AND OTHER SUBSTANCES PERMITTED AFTER ENTRY IN A RACE) & **#1844**

(AUTHORIZED MEDICATION). TRAINER **GEORGE REIDER** HAVING ONE (1) VIOLATION OF THIS RULE IN THE PAST THREE HUNDRED SIXTY FIVE (365) DAYS AND HAVING MET WITH THE STATE VETERNARIAN DR. EDUARDO DE LA CRUZ IS HEREBY FINED THE SUM OF **TWO HUNDRED FIFTY (\$250.00) DOLLARS** FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1844 (c) 1. AUTHORIZED MEDICATIONS.
