**Saturday**01/25/14 (1) **Wiseman Ruling****RULING # 12**

DRIVER **STEVE WISEMAN**, WHO DROVE “**FRANKLY SCARLETT**” IN THE FOURTH RACE ON JANUARY 24, 2014, IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1530** (CASES NOT COVERED – VIOLATION OF ‘CAL-EXPO HOUSE WHIPPING RULE’ – (4)(A) ANY BLATANT OR EXAGGERATED MOVEMENTS OF THE WHIPPING ARM WHICH WILL RESULT FROM RAISING THE ELBOW ABOVE THE DRIVER’S SHOULDER HEIGHT AND/OR ALLOWING THE HAND HOLDING THE WHIP TO REACH BEHIND THE DRIVER DURING THE USE OF THE WHIP).

The above ruling was issued after Wiseman accepted responsibility for taking his whip to far behind his head in the stretch drive of the fourth race.

01/25/14 (2) **Svensen Ruling****RULING # 13**

DRIVER **LEMOYNE SVENDSEN**, WHO DROVE “**JEN’S DELIGHT**” IN THE FOURTH RACE ON JANUARY 24, 2014 IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1530** (CASES NOT COVERED – VIOLATION OF ‘CAL-EXPO HOUSE WHIPPING RULE’ – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES UNTIL HORSE REACHES THE 7/8 MARKER).

The above ruling was issued after Svensen had to admit that he went to one handed whipping well before the 1/8 pole.

01/25/14 (3) **Luster [Ref: 01/24/14 (4)]**

George Luster appeared and denied striking the wheel of a foe in last night’s fifth race. Luster became belligerent, initially walked out, and would not listen to or accept the steward’s interpretation. Steward Oke was not in the hearing due to a track safety meeting. The matter will now be held over until a formal hearing can be convened.

01/25/14 (4) **Qualifiers**

Six (6) of nine (9) made the grade in tonight’s two qualifiers.

01/25/14 (5) **Celebrity Race**

Local radio personalities Dave “Deuce” Mason and Morgan Reagan teamed up with drivers Luke Plano and Gene Vallandingham respectively in a one

mile match race. Mason and Plano bested Reagan and Vallandingham by a narrow margin in the two seat Jog Cart competition.

01/25/14 (6) **More – Promotions Tonight**

Tonight is dollar beer, hot dog, and soda night. Also, handicapping contests provided by Smackline.com hosted by Dave “Deuce” Mason.

01/25/14 (7) **Minor/Disqualification – Ninth Race**

#7 “The Future” (Tyler Smith) was disqualified from the eighth and placed ninth after racing inside of two pylons at the top of the stretch. #7 was falling back and Driver Smith eased over to avoid traffic, but was caught and lapped on at the wire by #6 “Bo Knows Power” who had made an earlier break. Thus #7 had to be disqualified.

01/25/14 (8) **Goodbary Remembered**

The eleventh race was named in honor of the late Robert Goodbary DVM, who was State Veterinarian and a great friend to this Board of Stewards. A gathering of friends and family ate and drank in the Turf Club and somewhere in the vicinity of one hundred (100) of them paid their respects in a Winners Circle Ceremony.
