The racing office was open today and entries were accepted for racing on Saturday, October 19th. Fourteen (14) races were drawn and the racing office was open until 5:30pm. One hundred thirty three (133) horses are scheduled to start. Steward Wayne Oke was on duty.

A hearing was held today in the Cal Expo stewards' office. The CHRB filed a complaint against Exercise Rider Patricia Curtin for alleged violation of CHRB Rule 1874 (Disorderly Conduct). Along with the stewards present at today's hearing was Court Reporter Sherry Carter (Frazier Reporting). CHRB Investigator Carol Nolan presented the stewards a nine (9) page complaint along with San Joaquin County Fair Ruling #4 (Dated September 28, 2013) which suspended Patricia Curtin for failure to appear at a hearing in Stockton on September 27, 2013. That hearing was for alleged violation of CHRB Rule #1874 (Disorderly Conduct) on August 7, 2013 at the Sonoma County Fair in Santa Rosa. Test samples were obtained from Ms. Curtin on that day. Today's hearing, which was transcribed by Sherry Carter (Frazier Reporting), was a result of a test report provided by Quest Diagnostic Laboratories. Patricia Curtin was accompanied today by Trainer Lisa Dezotell who was acting as a representative. Testimony was given today and documents were entered into evidence. A decision in this matter will be forthcoming.

10/19/13 (2) **Qualifying Races**

Three (3) qualifying races were held today commencing at 4:30pm prior to this evening's fourteen (14) race pari mutual card. Out of the seventeen (17) participants, fifteen (15) made the grade.

10/19/13 (3) **Internet Down**

For this race week internet capability for the entire racing office building was shutdown. The racing department and enforcement unit were all affected.

10/19/13 (4) **Twelfth Race Inquiry**

The stewards posted the Inquiry sign after viewing an incident past the ¼ mile marker. Third place finisher #7 "It's Getting Hairy" (Tim Maier) made a break in stride at this juncture and the stewards wanted to investigate as to the reason why. Film review indicated that tenth (last) place finisher #10 "Brooklets Hicktown" (Lemoyne Svendsen) made a break in stride and that his misfortune led to interference with #7 "It's Getting Hairy" being interfered with. Being as the tenth place finisher interfered with the third place finisher there was nothing to warrant a disqualification. No change.
