Proceedings of the Board of Stewards for the period of Monday, November 26, 2012 through Sunday, December 2, 2012. Steward Grant Baker was the Reporting and Duty Steward for the enclosed period.

11/26/12 (1) Entry Day

The racing office was open today accepting entries for Friday, November 30 and Saturday, December 1.

11/26/12 (2) Dark Day

11/27/12 (1) Double Draw

The racing office was open today and races were drawn for Friday, November 30 and Saturday, December 1. Two (2) non wagering races (California Sires Stakes) will be contested before a sixteen (16) race pari-mutuel card on November 30. One hundred forty four (144) horses are scheduled to start on the pari-mutuel card.

One (1) non wagering race (California Sires Stake) and sixteen (16) pari-mutuel races are slated for December 1. One hundred thirty seven (137) participants are scheduled to face Starter Bill Vallandingham.

Scratches and changes for Friday, November 30 and Saturday, December 1, took place this morning in the racing office. Thirty three (33) driver changes and two (2) scratches were made for November 30. Non-Wagering Races Cancelled

Tonight's two (2) California Sire Stakes races were cancelled with next week looking like a better weekend to hold them due to a favorable weather forecast. These two (2) non-wagering events were called off with full agreement of horsemen, management and the California Sire Stakes committee.

11/30/12 (2)

Second Race Inquiry

The stewards posted the inquiry sign in order to review two (2) incidents that occurred during the running of this race. The first incident involved fifth place finisher #7 "RS Stormboat" (Richard Schneider) who made a break and then raced inside two (2) pylons approaching the 3/4th marker. Driver Schneider complied with the breaking rule (CHRB #1722) and did not violate Cal Expo pylon regulations.

In the second incident fourth place finisher #1 "Go Grace Go" (Lemoyne Svendsen) goes on a break in 'upper stretch' and then complies with the 'breaking rule' by losing considerable ground. After film review the stewards concurred that no change in the order of finish was warranted.

11/30/12 (3)

Track Condition

The racetrack, which was listed as 'good' for race one (1) and two (2), was downgraded to 'sloppy' prior to this evenings third race.

11/30/12 (4)

Sixteenth Race Inquiry/Disqualification

The stewards posted the inquiry sign in order to review an incident in the back of the pack. Race replays show original tenth place finisher #2 "Jane The Brain" (Williams Hernandez-Arriaga) veer inward into the path of ninth place finisher #7 "Hoosier GB Diamond" (Robert Roesch) who was racing up into a precarious position approaching the far turn. The actions of these two (2) drivers and/or horses caused eleventh (last) place finisher to hook wheels, go off stride and race inside pylons.

In a unanimous vote there was a double disqualification in this race. #7 “Hoosier GB Diamond” (Robert Roesch) was disqualified and placed tenth. #2 “Jane The Brain” (Williams Hernandez-Arriaga) was disqualified and placed eleventh (last). Both of these driver’s were ordered to film review with the stewards.

12/01/12 (1) **Driver Film Review [REF: 11/30/12 (4)]**

Provisional Driver Williams Hernandez-Arriaga (#2 “Jane The Brain”) and Driver Robert Roesch (#7 “Hoosier GB Diamond”) appeared in the steward’s office to review their drive in last night’s sixteenth race. Film review showed that penalties were not warranted.

- 12/01/12 (2) **Track Condition**
Periodic rain throughout the day led the stewards to officially rate the one (1) mile oval as sloppy.
- 12/01/12 (3) **First Race Inquiry**
The stewards posted the inquiry sign after viewing third place finisher #7 “Serious Art” (Tim Maier) make a break before the $\frac{3}{4}$ pole. After film review the stewards, in a unanimous decision, ruled #7 “Serious Art” complied with the CHRB Rule #1722 (Breaking). No change.
- 12/01/12 (4) **Second Race Inquiry**
The stewards posted the inquiry sign following this race in order to review possible interference between fourth place finisher #3 “Viking Mia” (James Kennedy) and fifth place finisher #1 “KD Amazin Spirit” (Scott Cisco). During the stretch drive of this race #1 “KD Amazin Spirit” appears to ‘throw his head’ and check slightly. The review of this race was to determine if #3 “Viking Mia” interfered with #1 “KD Amazin Spirit”. The stewards ruled #1 “KD Amazin Spirit” was getting out in the stretch, threw his head and caused his own problems. Unanimous decision. No Change.
- 12/01/12 (5) **Eleventh Race Inquiry**
The stewards posted the inquiry sign after viewing sixth place finished #1 “Blissfull Winds” (Gene Vallandingham) and ninth (last) place finisher #7 “Wildcats Major” (Daniel Gassien) race inside pylons racing down the backstretch.
- Video review shows #7 “Wildcats Major” driven off the racetrack, in sloppy conditions, for no obvious reason. “Wildcats Major” subsequently makes a break and loses all chance to beat anyone. At this point race rival #1 “Blissfull Winds” follows “Wildcats Major”, who was directly in front of him, off the racetrack and raced inside two (2) pylons. In a unanimous decision the stewards ruled there was nothing to warrant a disqualification. No change.
- 12/01/12 (6) **Twelfth Race Inquiry**
The stewards posted the inquiry sign after observing #2 “Good Tiger Falls” (Scott Cisco) go on a break in the stretch and at the finish. #2 “Good Tiger Falls” was in the back end of a tight three (3) way photo finish. Race replay shows #2 “Good Tiger Falls” comply with CHRB Rule #1722 by ‘losing ground’ following the break. In a unanimous decision ‘no change’ was made in the order of finish.
- 12/01/12 (7) **Thirteenth Race Inquiry**
The stewards posted the inquiry sign after viewing second place finisher #6 “Hi Tech Tony” (Daniel Gassien) make a ‘break’ before and after the start. Film review shows Driver Gassien and his horse comply with the ‘breaking rule’ (CHRB #1722) by taking his horse to the outside going into the first turn. In a unanimous decision ‘no change’ was made in the order of finish.

12/01/12 (8) **Fifteenth Race Inquiry**

The stewards posted the inquiry sign after viewing home stretch contact between second place finisher #1 “Scootin Higher” (James Lackey) and eighth place finisher #7 “Fairway Gypsy” (Scott Cisco).

Race replays failed to show who, if anyone, was at fault when the sulky arches of these two (2) rivals made contact with one another in mid-stretch. The stewards spoke with both drivers involved in the incident and reviewed all camera angles. #7 “Fairway Gypsy” made a break in stride following the aforementioned contact. After speaking to both drivers involved ‘no change’ was made in the order of finish.

12/01/12 (9) **Video Problems**

Pegasus Communications, the video supplier, for this meet reported problems with their uplink for races thirteen (13), fourteen (14), and fifteen (15). It is our understanding that the live signal of the thirteenth (13th) race was not ‘sent out’ to simulcast patrons at all and that races fourteen (14) and fifteen (15) were decimated in ‘freeze frame’ sequence. The signal for race sixteen (16), our final race, was back in good working order. Pegasus reported a ‘power surge’ as the reason for the problem.
