5/25/12 (1) **Qualifying Races**

Four (4) qualifying races were held prior to tonight's fourteen (14) race pari-mutuel card. Of the sixteen (16) participants fourteen (14) made the grade.

5/25/12 (2) **ED Visits**

California Horse Racing Board Executive Director Kirk Breed paid the steward's a visit in the judge's stand this evening. Numerous racing matters were discussed.

5/25/12 (3) **Fifth Race Inquiry**

The steward's posted the inquiry sign following this race after viewing an incident between second place finisher #1 "Tax Relief" (David Siegel) and fourth place finisher #7 "One And Only" (James Lackey). These horses made wheel disc contact with each other with 3/16th of a mile left to race. The replays of this race show equal responsibility of these horses and drivers as this minor accident did nothing to warrant a disqualification. The vote was unanimous.

5/26/12 (1) **Ralph Silvestri III Ruling**

Driver Ralph Silvestri III failed to show up to drive "Thouartthegreatest" in the eleventh race Friday, May 25, 2012. Silvestri appeared in our office as ordered today and was asked why he didn't contact the stewards to inform us of his absence. He stated he hurt his shoulder in his horses' stall earlier in the day. The stewards told Silvestri to inform them when health issues are a concern. Driver Silvestri said he would. The stewards told

Silvestri to get a 'medical clearance' before he resumes driving. In a unanimous decision the stewards issued the following ruling:

RULING # 41

DRIVER **RALPH SILVESTRI III**, WHO WAS SCHEDULED TO DRIVE "**THOUARTTHEGREATEST**" IN THE ELEVENTH RACE FRIDAY, MAY 25, 2012 AT CAL EXPO CALIFORNIA IS HERBY FINED FIFTY (\$50.00)* DOLLARS FOR FAILURE TO FULFILL HIS DRIVING ENGAGEMENT; A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY (DRIVER) AGREEMENT).

5/26/12 (2) **Non-Wagering Early (1st) Race/Inquiry**

This early (5:30 post) non-wagering event was a California Sires Stakes Trot for 3 year olds (Purse \$12,000). Following this six (6) horse event the stewards posted the inquiry sign. The steward's wanted to investigate if third place finisher #4 "El Azteca" (Richard Wojcio) complied with CHRB Rule #1722 (Breaking) after making a break in the stretch. Following a film review the stewards all agreed that #4 "El Azteca" did comply with Rule #1722 and that no change in the order of the finish was warranted.

5/26/12 (3) **First Race Inquiry**

The stewards posted the inquiry sign after viewing an incident on the far turn during this seven (7) horse maiden event. This incident involved third place finisher #1 "Hailey Girl" (David Siegel) pulling out from his original inside position with 5/16th of a mile to race. At about this same time seventh place finisher #5 "Featured Star" (Tim Maier) goes on a break. The purpose of this inquiry was to determine if the actions of Driver Siegel and "Hailey Girl" contributed to the fact that #5 "Featured Star" lost his pacing gait and went on a 'break'. The stewards spoke with both drivers involved. After film review it was determined that race replays were inconclusive and the stewards unanimously decided to let the original order of finish to stand. No change.

5/26/12 (4) **Fifth Race Inquiry/Disqualification**

The stewards briefly posted the inquiry sign after viewing seventh place finisher #7 "Connie's Lady" (James Kennedy) race inside several pylons after the ¾ pole and through the early stretch. This action took place following "Connie's Lady" making a break in stride. For violation of the 'Cal Expo Pylon Rule' the stewards unanimously voted to disqualify #7 "Connie's Lady" and place her eighth (last).

5/26/12 (5) **Twelfth Race Inquiry**

The stewards posted the inquiry after viewing contact between first place finisher #2 "Fairway Gypsy" (Scott Cisco) and second place finisher #4 "Hezadilly" (Robley Johnson). This incident took place after the ¼ pole

as these rivals began their backstretch run. Race replays showed these horses make 'wheel disc' contact however video replays were inconclusive as to what led to this incident. Conversation with both drivers took place also. In a unanimous decision 'no change' was made in the order of finish.
