At 9:10 AM a draw was conducted for Friday's card with one hundred fifteen (115) head drawn to compete in fifteen (15) races.

Entry Refused

Owner Tricia McConnell who has failed to meet the conditions imposed on her by the Cal Expo Board of Stewards in Ruling #42 issued as a result of California Horse Racing Board Complaint #11SW0053, had her entry

refused pending a meeting with the stewards on Friday March 30, 2012. (More to follow).

3/27/12 (3) **Detention Barn**

Cal Expo Management announced a plan to place randomly selected horses in a secure 'detention barn' at 1:30 PM on the day these horses are scheduled to race.

3/27/12 (4) **Horse Eligibility Question**

Following today's draw a question was raised concerning the eligibility of the Tim Brown trained "Double Dakota" in Saturday evening's second race.

Of concern was the fact that this horse had been an injured scratch on March 23, 2012 in a \$3,500.00 claiming event and entered to race on March 31, 2012 in a \$5,000.00-\$6,000.00 claiming handicap.

The duty steward consulted Cal Expo Director of Racing Dave Elliott and Racing Secretary Fred Kuebler and was informed that this policy was in effect during the tenure of Sacramento Harness and was not a policy of Cal Expo Management.

The situation does not violate any California Horse Racing Board regulation.

The duty steward polled the Board of Stewards by telephone and by majority vote (Steward Will Meyers dissenting) determined that the horse was properly entered.

The duty steward received faxes from Owners Alex Toman, Edwin Anthrop and Leon Layne informing that their horses currently stabled at Cal Expo in the care of Trainer Richard Dunneback are being transferred immediately to the care of Trainer Earl Kennedy.

3/28/12 (2) **Scratch Time for Friday and Saturday Cards**

At scratch time for Friday's card there were numerous driver corrections and one (1) injured scratch.

Five (5) horses were randomly selected to be placed in detention prior to competing on Friday's card.

At scratch time for Saturday's card there were numerous driver corrections, one (1) claiming price correction and one (1) injured scratch. Eleven (11) horses were randomly selected to be placed in detention prior to competing on Saturday's card.

Owner Tricia McConnell having provided the Board of Stewards with proof of having complied with the conditions set forth in Cal Expo Ruling #42 her horse has been removed from the steward's list and entries will be accepted.

Gene Vallandingham/ Film Review

Driver Vallandingham appeared as requested to review his drive in Saturday's March 24, 2012 third race.

Driver Vallandingham's mount #5 "Asgoodasioncewas" was noticeably 'lagging' off the gate and not keeping up particularly well throughout the event although he finished strongly to be 5th in the final order of finish. At issue as well was the increased frequency of this habit.

Driver Vallandingham was quite candid with the Board of Stewards in his agreement that he had become rather lax in this area and would make a concerted effort to improve his performance within the areas of concern. Driver Vallandingham accepted the following penalty relative to his drive on March 24.

RULING # 26

DRIVER GENE VALLANDINGHAM, WHO DROVE "ASGOODASIONCEWAS" IN THE THIRD RACE ON SATURDAY, MARCH 24, 2012, IS HEREBY FINED THE SUM OF FIFTY (\$50.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1731 (G) (DRIVER INFRACTIONS [STARTING RULES] – FAILURE TO COME UP INTO POSITION).

Qualifying Races

Four (4) qualifying races were conducted commencing at 4:30 PM. In these events seventeen (17) of the twenty-three (23) participants were successful in their qualifying entries.

3/30/12 (5)

Race #3 Inquiry/Change

The 'inquiry' sign was posted in order to review the actions of #4 "Cherry Tree Nicole" (Tim Maier) in the stretch.

After reviewing video the stewards unanimously concluded that #4 who was 'off-stride' from mid stretch through the finish was in violation of the Breaking Rule, thus #4 was disqualified from fifth and placed sixth.

Driver Tim Maier was held blameless in the incident.

3/30/12 (6) **Race #9 Inquiry/Disqualification**

The 'inquiry' sign was posted in order to review the actions of #8 "Exquisite Gem" (James Kennedy) the eventual fourth place finisher, at the wire.

After reviewing video and utilizing the photo finish images the stewards unanimously concluded that #4 who broke stride in deep stretch was 'lapped on' by #3 "Wanna Glide" (Steve Wiseman) thus #4 was in violation of the Breaking Rule and was placed fifth.

Driver Kennedy was held blameless in the incident.

3/30/12 (7) **Race #9 Steward Paddock Observation**

On a visit to the paddock in the interval between races 8 and 9 steward Grant Baker observed the groom on #4 "Eggwhite In My Beer" trained by Kennedy Lindsey fall down get up and to be unsteady on his feet.

Steward Baker reported his concerns to the investigative staff.

3/31/12 (1) **Changing Weather**

The evening's program began with the track listed as 'sloppy' a result of early morning rain.

At the conclusion of race #2 the track was improving and as a result the track condition was upgraded to 'good.'

A torrential downpour after race #5 resulted in the track condition being once again listed as 'sloppy' for the remainder of the card.

3/31/12 (2) **Race #6 Inquiry/Disqualification**

The 'inquiry' sign was lit in order to review the actions of eventual fifth place finisher #3 "Gusty Winds Ahead" (Scott Cisco) in the stretch.

After reviewing video the stewards unanimously concluded that #3 had been inside multiple pylons in the stretch a violation of the 'Pylon Rule.'

Thus #3 was disqualified and placed seventh. Driver Scott Cisco will attend film review on April 5, 2012 to discuss his actions in the incident. More to follow.

3/31/12 (3) **Race #11 Inquiry/No Change**

The 'inquiry' sign was lit in order to review the actions of #10 "My Real Love" (L. Svendsen) who broke stride immediately after the start.

The stewards unanimously concluded that #10 had complied with the breaking rule thus no change.

3/31/12 (4) **Race #14 Inquiry/Disqualification**

The 'inquiry' sign was lit in order to review an incident in the stretch when #5 "RW Island Spirit" (James Lackey) who was leading at that point in the race 'bore in' and was inside the pylons. Driver Lackey realizing this corrects to his right and in doing so makes contact with left foreleg of #1 "Persuade Me" (Lemoyne Svendsen) causing her to 'break stride' resulting in interference to the trailing horses.

After reviewing video and speaking with Drivers Svendsen and Lackey the stewards in an unanimous decision disqualified #5 and placed her ninth for interference with #1 as well as a violation of the 'Pylon Rule.'

Driver Lackey will meet with the stewards on Saturday April 7, 2012 to review the video. More to follow.
