DRIVER LUKE PLANO, WHO WAS SCHEDULED TO DRIVE “LITTLE WATER TOWER” (FIRST RACE), “WINSOM KELLY” (SECOND RACE), “SILVER BLOOM” (THIRD RACE), “STILL STYLIN” (FOURTH RACE), AND “MAJESTIC LASS” (FIFTH RACE) ON MARCH 16, 2012 AT CAL EXPO CALIFORNIA IS HEREBY FINED ONE HUNDRED (\$100.00) DOLLARS FOR FAILURE TO FULFILL NUMEROUS DRIVING ENGAGEMENTS; A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY (DRIVER) AGREEMENT).

The above ruling was issued after Plano failed to make the first five (5) races last night. Plano’s plane was delayed in San Francisco and traffic to Sacramento held him up further.
