In an event made possible through the co-operative effort of Cal Expo Management and the California Harness Horseman's Association all drivers participating at Cal Expo were afforded the opportunity to be in compliance with CHRB Rule 1498 and a majority took advantage of the opportunity.

Qualifying Races were conducted prior to tonight's card with seven (7) of ten (10) meeting the qualifying standard.

1/7/12 (5) **Race #1 – Inquiry/Disqualification**

The "Inquiry" sign was posted to review the actions of 5th place finisher #5 "Mr Me" (Susan Boyce) who broke stride at the head of the stretch and continued "Off-Stride" through the finish.

After reviewing video the stewards unanimously concluded that #5 was in violation of the Breaking Rule (Extended Break). Thus #5 was disqualified and placed 6th (last). Driver Boyce was held blameless in the incident.
