- 01/15/11 (1) **Isbell In**
 Provisional Driver Karen Isbell was in to review last night's fifth race in which she finished eighth (8th) aboard #6 "Red Star Brea". Isbell was candid in the fact she drove into the wheel of a rival at the finish line. The action had no effect on the outcome of the race, but was careless, thus the following ruling was issued:

Ruling # 06

Provisional Driver Karen Isbell, who drove "Red Star Brea" in the Fifth Race on Friday, January 14, 2011, is hereby fined the sum of One Hundred Dollars (\$100) for violation of California Horse Racing Board Rule #1721(B) (Driving Rules – Jostle, Strike, Hook Wheels, or Interfere With Another Horse or Driver).

- 01/15/11 (2) **Silvestri III In**
 Provisional Driver Ralph Silvestri III was in to review a drive from last night. In Race #3, it appeared Silvestri III may have pulled his horse #4 "Desired Result" late on #6 "C'mon Sweet Mariah" (Rocky Stidham). The pair was in the back of the pack at the time of the incident and the cameras were unable to catch the action completely. Silvestri was therefore given a warning.
- 01/15/11 (3) **Ninth Race – Inquiry/No Change**
 #3 "Vinnys Dance" (Rick Plano) made three short breaks, one after the 1/2 mile pole and two after the 3/4 pole. #3 finished third (3rd), therefore the inquiry sign was posted to assure compliance with the breaking rule. #3 complied and no interference was detected. No change.
- 01/15/11 (4) **Tenth Race – Driver Questioned**
 Following the running of the 10th race, Steward Oke called Driver Chris Hernandez to ask why he pulled his horse from the two hole after the 1/2 mile pole to get behind a horse that had been parked.

Mr. Hernandez became belligerent, cursing and threatening. Mr. Oke ordered him to the steward's office on Thursday and Hernandez said he would not show. Investigator Carol Nolan was apprised of the situation. More to follow.

01/15/11 (5) **Thirteenth Race – Inquiry/No Change**
 #4 “Jaccka Invoke N” (J. Kennedy) suffered a flat tire near the 3/4 pole.
 #5 “Jessalilpeace” (R. Silvestri III) was trailing #4 at the time and may have caused the flat. However, tapes were inconclusive, in no small part due to heavy fog.
