Proceedings of the Board of Stewards for the period of Monday, September 20, 2010 through Sunday, September 26, 2010. Steward Brent McLaren was the Reporting and Duty Steward for the enclosed period.

09/20/10 (1) **Entries and Draw**

Entries were taken for Thursday, Friday and Saturday's cards this morning. Two hundred seventy four (274) was the total number of entries for the three (3) days. Thursday's card had seventy four (74) entries to fill a ten (10) race card.

9:00 a.m. was scratch time for Thursday's card. There were twenty one (21) driver corrections, three (3) trainer changes, two (2) first time Lasix, and one (1) claiming price correction.

Friday's draw had ninety six (96) entries to fill thirteen (13) races, while Saturday's draw had one hundred three (103) entries to fill thirteen (13) races.

Scratch time for Friday and Saturday was 9:00 a.m. For Friday there were sixteen (16) driver corrections, three (3) early scratches and one (1)

addition of Lasix. Saturday had twelve (12) driver corrections and two (2) trainer changes.

09/23/10 (1) **Tenth Race – Inquiry**

The stewards hung the inquiry sign concerning possible interference between #4 “Paul The Powerful”, driven by Ralph Silvestri and #6 “Gee Gee Cyril Lee”, driven by Richard Wojcio, in the stretch. After review of the race, the stewards disqualified #4 for putting a wheel under #6 causing interference in the stretch.

09/24/10 (1) **Driver Review**

Driver Ralph Silvestri III came to the steward’s office at 4:30 p.m. to review two (2) races on Thursday, September 23, 2010. First Race, the #2 “RW Island Spirit”, driven by Mr. Silvestri went inside two (2) pylons after the start of the race. Mr. Silvestri explained the horse moved to the inside so fast he didn’t have a chance to correct the movement.

The second incident was in Race #10, the #4 horse “Paul The Powerful”, driven by Mr. Silvestri, was disqualified by the stewards for having a wheel underneath and forcing wide in the stretch, #6 “Gee Gee Cyril Lee”, driven by Richard Wojcio. Mr. Silvestri explained that he wanted to get clear with his horse that had pace, so as to try to win the race. By watching the films he did see how close he came to the #6 horse when making this move.

At the end, Mr. Silvestri could understand why he was disqualified from third (3rd) to fifth (5th).

Pegasus Video employees were late for the qualifiers, so the 1st Race was not taped.

09/25/10 (2) **Fourth Race – Inquiry**

The stewards hung the inquiry sign concerning the breaking horse #2 “Still Stylin”, driven by James Kennedy, after the 3/4 pole. After review, the stewards placed #2 from fifth (5th) to sixth (6th) for interference while on a break to #3 “Latino Hall”, driven by Kevin Anderson.

09/25/10 (3) **Eighth Race – Inquiry**

The stewards hung the inquiry sign concerning the #2 horse “Lodi Cooper”, driven by Rocky Stidham, for possible pylon violation past the 3/4 pole.

After reviewing the films, the stewards felt that even though the #2 horse did go inside two (2) pylons, that the horse did not gain enough of an advantage to warrant a disqualification. The driver, Rocky Stidham, was fined one hundred (\$100) dollars for the violation.
