Sixty five (65) horses are entered for Thursday's nine (9) race card. No Cal-Bred races were used.

09/09/10 (1) **Silvestri Ruling – Ref: 09/04/10 (3)**

Ruling # 08

Driver Ralph Silvestri III, who drove "Adora" in the Fifth Race on Saturday, September 04, 2010, is hereby Suspended Three (3) Racing Days commencing on Thursday, September 16, 2010, through Saturday, September 18, 2010 for violation of California Horse Racing Board Rule #1721 (B) (Driving Rules – Jostle, Strike Or Interfere With Another Horse).

The above ruling was issued after Silvestri reviewed his drive from last Saturday. Silvestri agreed it was his responsibility to clear horses when he is attempting to pass. Steward Oke felt five (5) days were in order.

09/09/10 (2) **Steward to Start**

Steward Brent McLaren will start the horses tonight. Starter Bill Vallandingham had a five way emergency bypass operation on Wednesday. A replacement starter will arrive tomorrow. Gene Montgomery is a licensed starter flying in from Illinois.

09/09/10 (3) **Fourth Race – Inquiry/No Change**

#2 "Gee Gee Cyril Lee" (Luke Plano) went off stride while leading approaching the 1/2 mile pole. The inquiry sign was posted to assure compliance with the breaking rule and also that no other horses were interfered with at that point. #2 complied and no interference was detected. No change.

09/09/10 (4) **Seventh Race – Disqualification**

#2 "Mr Me" (Etienne Desomer) went off stride and inside the pylons the length of the stretch, finishing seventh (7th) of eight. #2 was placed eighth (8th) for violation of both the pylon and breaking rules.

Friday09/10/10 (1) **Jason Maier Ruling****Ruling # 09**

Trainer Jason Maier, who started "Missniobekniobe" in the First Race on Thursday, September 9, 2010, is hereby fined the sum of Fifty Dollars (\$50) for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Late Arriving In Paddock).

The above ruling was issued after Maier was contacted and offered no excuse for being five minutes late for the first race.

- 09/10/10 (2) **Second Race – Late Scratch/No Show Wagering**
A late declaration of #2 “Sweet Treats” (Tim Maier) reduced the field to four (4) wagering interests. Show wagering was cancelled in accordance with California Horse Raced Board Rule #1954 (Pari-mutuel Pools).
- 09/10/10 (3) **Eighth Race – Inquiry/No Change**
#4 “Bettor Approval” (Tim Maier) went offstride at the start and recovered and finished third (3rd). After review it was determined that #4 complied with the breaking rule and no change was warranted.
- 09/10/10 (4) **Eleventh Race – Late Scratch Post Parade**
#7 “Awesome Deal” (Trainer Greig Watson) threw a fit in the post parade and was declared by order of the stewards,

- 09/11/10 (1) **Silvestri III Fined**
- Ruling # 10**
- Trainer Ralph Silvestri III, who started “K D Rowdy One” in the Tenth Race on Friday, September 10, 2010, is hereby fined the sum of Fifty Dollars (\$50) for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Late Arriving in Paddock).*
- The above ruling was issued when #1 “K D Rowdy One”, trained by young Silvestri arrived five (5) minutes late to the paddock for last night’s 10th Race.
- 09/11/10 (2) **Sobey Ruling**
- Ruling # 11**
- Horse Identifier Carl Sobey is hereby fined the sum of One Hundred Dollars (\$100) for failure to handle his business in a proper manner during Qualifying Races on Saturday, September 04, 2010. A violation of California Horse Racing Board Rule #1554 (Duties of Horse Identifier).*
- The above ruling was issued after Identifier Carl Sobey failed to catch a mistaken name in the qualifying races last Saturday. “Derrick Bromac N” should have been “Davbro Bromac N”. Sobey accepted the penalty and no records were affected.

- 09/11/10 (3) **Qualifiers**
Thirty (30) of thirty four (34) made the grade in today's seven (7) qualifying races.
- 09/11/10 (4) **Second Race – Recall**
#3 (PP2) "Dani California" (Tim Maier) bore out at the start interfering with #1 (PP3) "Berkshire" (Steve Wiseman). Starter Gene Montgomery ordered a recall. The horses were reassembled and off after a three (3) minute delay, with no further incident.
- 09/11/10 (5) **Sixth Race – Inquiry/No Change**
#3 "Twice The Ruckus" (Luke Plano) went offstride in the stretch, finishing fourth (4th). The inquiry sign was lit to assure no interference occurred and that the breaking rule was complied with. #3 complied and no interference was noted. No change.
- 09/11/10 (6) **Seventh Race – Accident Prior to the Start**
As the horses were coming to the start, #1 "White Trash" started bucking and unseated Amateur Driver Brevator Creech. Outrider Billy Don Wainscott did an excellent job of capturing the runaway. #1 was scratched by the stewards and placed on the Steward's List for being unmanageable. Driver Creech was checked by the paramedics and allowed to fulfill his engagement in the 11th Race.
- 09/11/10 (7) **Seventh Race – Inquiry/No Change**
The inquiry sign was posted to review possible interference down the backside involving the winner #5 "Long Last Look" (Robert Stepien) and fifth (5th) place finisher #7 "Freedom Art" (Chris Hernandez). It first appeared that #5 pulled late down the backside, forcing #7 three wide. After review and talking to the drivers, no change was made. Room existed for #5 to pull, as #7 was already racing wide at the time and left room to his inside.
