Proceedings of the Board of Stewards for the period of Monday, May 03, 2010 through Sunday, May 09, 2010. Steward Will Meyers was the Reporting and Duty Steward for the enclosed period.

Monday

05/03/10 (1) **Entries for Thursday**
Eighty seven (87) horses are entered for Thursday's twelve (12) race card.
No Cal-Bred races were used.

05/03/10 (2) **Dark Day**

05/04/10 (1) **Scratches for Thursday -Entries for Friday & Saturday**
One driver change and one scratch were submitted for Thursday. Friday's sixteen (16) race card drew one hundred seventeen (117) entries while one hundred seventeen (117) horses were also drawn for Saturday's sixteen (16) races. The sixteen (16) races for both days include fifteen (15) wagering races and one (1) non-wagering sire stakes on each day. Four (4) Cal-Bred sire stakes were carded for the two days.

05/04/10 (2) **Dark Day**

05/05/10 (1) **Scratches for Friday and Saturday**
Numerous driver changes were recorded for Friday and Saturday. No scratches were submitted.

05/05/10 (2) **Dark Day**

Thursday**05/06/10 (1) Silvestri III Ruling****Ruling # 66**

Trainer Ralph Silvestri III, who started “Magicality” in the First Race on January 30, 2010, is fined the sum of Five Hundred (\$500) Dollars pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (D) (Medications, Drugs and Other Substances – Prohibited Substance - Dexamethasone - Class IV That Carries a Class C Penalty).

The above ruling was issued after due deliberation and penalty guideline review. This was Silvestri’s first violation as a trainer, but he has held that license for less than a year.

05/06/10 (2) Vets Complain

Dr. Charles Smith and Dr. Kathryn Jones were in to complain that the unofficial program, which the association provides for a dollar, had the wrong information. Evidently races from two different days were mixed together. We explained that the stewards had nothing to do with those copies and only work from the official program.

Bridget Desomer, who makes the copies, arrived in the office and made good copies for the two doctors; end of problem.

05/06/10 (3) Qualifiers

Ten (10) of thirteen (13) made the grade in tonight’s three (3) qualifying races.

05/06/10 (4) Glitches

The timer failed to operate for the qualifying races which were then hand timed. Jack of all trades Frank Matthews of Pegasus video fixed the problem before the first race.

The computer link from the steward’s stand to the tote system failed to operate for the first race. Directions were given by phone to tote operators for the lock of the system and placing of numbers and official results. The link had been improperly logged on in the tote room. The problem was recognized and fixed for the remainder of the card. The incident did not affect wagering.

The photo finish system failed for the eighth race. Camera Operator Vickie Colby could not explain the problem. Luckily all horses were racing in the clear at the finish. The problem was corrected for the remainder of the card.

05/06/10 (5) Tenth Race – Inquiry/Disqualification

#2 “Mr Me” (Kennedy Lindsey) went off stride in the stretch, finishing sixth (6th). #2 was placed eighth (8th) for failing to lose ground while off stride, in violation of the breaking rule.

05/06/10 (6) **Outrider Injured**
 Outrider Billy Don Wainscott was injured following the last race. He apparently fell in the infield while cutting across from the frontside to the backside. Details are uncertain, but the ambulance crew transported him to U.C. Davis Hospital.

 Billy Don Wainscott is in ICU at U.C. Davis for three or four broken ribs, a fractured skull and a laceration over his right eye as of this writing.

05/07/10 (2) **Succarotte Ruling [Ref: 05/01/10 (4)]**

Ruling # 67

Driver Anthony Succarotte, who drove "Fast N Furious" in the Thirteenth Race on Saturday, May 01, 2010, is hereby fined the sum of Two Hundred Dollars (\$200) for violation of California Horse Racing Board Rule #1721 (E) (Driving Rules – Crowd a Horse or Driver by Putting a Wheel Under Him). This incident occurred before the 1/4 mile marker.

The above ruling was issued after Succarotte appeared and reviewed the 13th Race from last Saturday. Succarotte admitted his mistake, but was not pleased with the amount of the fine.

05/07/10 (3) **Tractor Mishap**
 While harrowing for the 5th Race the roller came unhitched from the lead tractor near the finish line. The maintenance crew did a good job of removing the roller and the second tractor and harrow finished harrowing the track. A delay of approximately ten minutes was the result. Original post was 7:23 p.m. and the race was off at 7:33 p.m. The roller was fixed by the next race.

Ruling # 68

Trainer Christopher Conrad, having appeared telephonically before the Cal Expo Board of Stewards in response to California Horse Racing Board Complaint #09SW-0216, is hereby suspended for a period of Ninety (90) Days – May 16, 2010 through August 13, 2010 for violation of California Horse Racing Board Rule #1840 (Veterinary Practices and Treatments – Trainer Treated Horse Pre-Race), Rule #1890 (A) (Possession of Contraband – Needle and Syringe) and Rule #1902 (Conduct Detrimental to Horse Racing).

The above ruling was issued after deliberation and research of like violations. Possession of a needle and syringe is a violation. Utilizing it on a horse on race day is a serious offense. The penalty most likely would have been stiffer had the contents of the syringe or the test samples of the horse proved positive.
