Proceedings of the Board of Stewards for the period of Monday, December 14, 2009 through Sunday, December 20, 2009. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

12/14/09 (1) Entries and Draw for Thursday 12/17/09

Entries were taken and a draw held for Thursday's card. At the 1:00 p.m. draw one hundred ten (110) head were drawn to compete in twelve (12) events. Scratch time is tomorrow at 9:00 a.m.

At scratch time there were thirty (30) driver corrections and no other changes.

12/15/09 (2) Entries and Draw for Friday 12/18/09 & 12/19/09

Entries were taken and a double draw conducted for Friday and Saturday's cards. At the 1:30 p.m. draw for Friday's card, one hundred thirty three (133) head were drawn to compete in fifteen (15) races. Immediately following, Saturday's card was drawn with one hundred thirty seven (137) head drawn to compete in fifteen (15) pari-mutuel events, plus four (4) California Sire Stake events to be contested as 'non betting' races with first post at 4:00 p.m.

At scratch time for Friday's card there were eighteen (18) driver corrections and no other changes or corrections.

12/16/09 (2) **California Sire Stakes Finals for 2 Year Old Trotters & Pacers**

Prior to Saturday's regular race program, the finals for 2 year old trotters and pacers will be conducted as 'non betting' events.

Events for 2 year old trotters (4), 2 year old colt and gelding trotters (6), 2 year old filly pacers (6) and 2 year old colt and gelding pacers (6), each division competing for a purse of \$25,000.

12/16/09 (3) **Formal Hearing – CHRB Complaint #09SW-0157**

A formal hearing was held in the Cal-Expo steward's office to formalize a stipulated agreement between Owner/Trainer Francisco Chavez and the California Horse Racing Board. Licensee Chavez testified telephonically from Turf Paradise Race Course in Phoenix, Arizona. The hearing was recorded by Wendy Frazier of Frazier Reporting.

The California Horse Racing Board was represented by Supervising Special Investigator Gregg Fabbri.

The stipulated agreement was entered on the record with no objections and the record was closed. The following rulings were issued:

Ruling # 45

Trainer Francisco Chavez, who started the horse "Hold The Peace" in the Eighth Race at The California State Fair on September 6, 2009, having entered into a stipulated agreement with the California Horse Racing Board, is fined Three Thousand (\$3,000) Dollars and Suspended for thirty (30) days (December 28, 2009 through January 26, 2010) pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (Medications, Drugs and Other Substances – Ractopamine - Class III).

Pursuant to the terms of the stipulated agreement, fifteen days of the suspension are stayed pending the passage of one year from the date of this agreement, during which time the subject is placed on probation and shall not have any violations for Class I, II, or III substances. Actual days of suspension served will be December 28, 2009 through January 11, 2010.

Ruling # 46

A report from the University of California, Davis Analytical Laboratory, the official laboratory for the California Horse Racing Board, reported that urine sample, #F05767, taken from the horse "Hold the Peace", third place finisher in the Eighth Race at the California State Fair, Sacramento, CA on September 06, 2009 contained the prohibited drugs substance "Ractopamine" (Class III). It is hereby ordered per stipulated agreement

with The California Horse Racing Board dated December 3, 2009 that “Hold The Peace” be disqualified from all purse monies earned and deemed unplaced in accordance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies earned or awarded to Owner/Trainer Francisco Chavez (\$1,425) and Jockey Pablo Flores (\$60) be returned to the C.A.R.F. (California Authority of Racing Fairs) paymaster of purses for redistribution pursuant to California Horse Racing Board Rule #1760 (Purse Award or Prize to be Withheld).

12/16/09 (4) **Formal Hearing – CHRB Complaint #09SW-0132**

A formal hearing was held in the Cal-Expo steward’s office to address the disqualification of the horse “Chartleysmonalisa”, owned by Ralph Silvestri III and trained by Frank Petrelli. In addition to the owner and trainer, the hearing was attended by Supervising Special Investigator II Marty Snezek, along with Stewards Baker, Meyers and Oke. The proceedings were recorded by Wendy Frazier of Frazier Reporting. The hearing was opened, information was placed on the record and the following ruling was issued:

Ruling # 47

Acting upon a report from University of California, Davis, an official laboratory for the California Horse Racing Board, that the pre race sample #TC-188247, taken from the horse “Chartleysmonalisa”, the second place finisher in the Fifth Race on July 25, 2009, at Cal-Expo, had a pre race Total Carbon Dioxide (TCO₂) reading of 39.0 millimoles per liter of blood, in excess of allowable limits, it is ordered that “Chartleysmonalisa” be disqualified from all purse monies earned in said race, in accordance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that the owner of “Chartleysmonalisa” (Ralph Silvestri III) return all purse monies (\$540) to the paymaster of purses for redistribution in accordance with California Horse Racing Board Rule #1760 (Purse Award or Prize to be Withheld).

It is further ordered that Driver Steve Wiseman (\$30) and Trainer Frank Petrelli (\$30) return all purse monies to the paymaster of purses for redistribution in accordance with California Horse Racing Board Rule #1760 (Purse Award or Prize to be Withheld).

12/17/09 (2) **Second Race – Inquiry/Disqualification**

The stewards lit the 'inquiry' sign at the conclusion of Race #2 to investigate an incident in the stretch when the eventual second (2nd) place finisher #4 "Andover Victory" (Rick Plano) was observed to be 'off stride' multiple (3) times during the stretch drive. After reviewing film, the stewards unanimously concluded that #4 was guilty of violating the breaking rule; subsequently #4 was disqualified and placed seventh (7th). Driver Plano was held blameless.

12/17/09 (3) **Eighth Race – Inquiry/No Change**

The stewards lit the 'inquiry' sign at the conclusion of Race #8 to investigate an incident past the 3/4 mile marker when the eventual race winner #1A "Stanza" (Tim Maier) broke stride. After reviewing films, the stewards unanimously concluded that #1A had complied with the breaking rule, thus no change.

12/18/09 (1) **Third Race – Inquiry/No Change**

The stewards lit the ‘inquiry’ sign at the conclusion of Race #3 to investigate multiple breakers in the race, most particularly #3 “C Miracle Mary” (Richard Bertrand), the eventual third (3rd) place finisher. After reviewing films, the stewards unanimously concluded that all horses complied with the ‘breaking rule’, thus no change.

12/18/09 (2) **Fifth Race – Ridgeling/Gelding**

As the horses were leaving the paddock for Race #5, the stewards were informed that #6 “Enemy Lines”, trained by Dario Solares, programmed as a ridgeling was in fact a gelding, by Identifier Carl Sobey. The stewards informed the public via the announcer and the TV monitors of the fact and, due to the lateness of this revelation allowed the horse to compete. “Enemy Lines” finished second (2nd) in the event. All information was turned over to Supervising Special Investigator I Gregg Fabbri for review.

12/18/09 (3) **Eighth Race – Inquiry/No Change**

The stewards posted the ‘inquiry’ sign at the conclusion of Race #8 to investigate the start, in particular #10 “Sweetie of Lodi” (James Lackey) and an incident at the 3/4 mile marker involving fifth (5th) place finisher #5 “Doit By The Clock” (Steve Wiseman). In both instances there were no violations, thus no change.

12/18/09 (4) **Tom Wine Hearing – CHRB Case #09SW-0191**

A formal hearing was convened in the Cal Expo steward’s office to address the above referenced case. Present at the hearing were the Cal Expo Board of Stewards, California Horse Racing Board Supervising Special Investigators Gregg Fabbri and Marty Snezek, State Veterinarian Dr. Robert Goodbary and Respondent Tom Wine II. The proceedings were recorded by Wendy Frazier of Frazier Reporting. The record was opened, exhibits were entered on the record, and after a brief discussion, all parties agreed to a \$2,500 fine. Thus the following ruling was issued:

Ruling # 48

Trainer Tom Wine II, who started the horse “Hard On The Heart” in the Ninth Race at Cal Expo on November 08, 2009, is hereby fined the sum of Two Thousand Five Hundred (\$2,500) Dollars pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (D) (Medications, Drugs and Other Substances – Phenylbutazone (13.16 ug/ml) in Excess of Permitted Level – 3rd Offense in 365 Day Period - Class IV).

12/18/09 (5) **Frank Petrelli Hearing – CHRB Case #'s 09SW-130 and 09SW-131**

A formal hearing was convened in the Cal Expo steward's office to formalize a stipulated agreement between the California Horse Racing Board and Licensee Frank Petrelli. In attendance were Stewards Baker, Oke and Nicolo, California Horse Racing Board Supervising Special Investigator I Gregg Fabbri, and Respondent Frank Petrelli. The proceedings were recorded by Wendy Frazier of Frazier Reporting. The record was opened, the pertinent documents were entered as exhibits and the record was closed. Subsequently, the Board of Stewards issued the following ruling:

Ruling # 49

Trainer Frank Petrelli, who started the horse "Chartleysmonalisa" in the Fifth Race at Cal Expo Harness on July 25, 2009, having entered into a stipulated agreement with the California Horse Racing Board, is fined Three Thousand (\$3,000) Dollars and Suspended for thirty (30) days (December 20, 2009 through January 18, 2010) pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rules #1843.6 (D-1) (Total Carbon Dioxide – 39.0 millimoles per liter – Exceeds Permitted Level – Class III) and California Horse Racing Board Rule #1890 (Possession of Contraband).

Pursuant to the terms of the stipulated agreement, fifteen days of the suspension are stayed pending the passage of one year from the date of this agreement, during which time the subject is placed on probation and shall not have any violations for Class I, II, or III substances. At approximately 6:30 p.m., the Board of Stewards was contacted by Senior Special Investigator II Marty Snezek to inform the Board of Stewards that he was on-site and would be assisting in the investigation.

Later, the Board of Stewards was informed that Senior Special Investigator II Marty Snezek and Supervising Special Investigator I Gregg Fabbri had gathered evidence and submitted same to the U.C. Davis lab for analysis. All other entrants (4) trained by Christopher Conrad were sent to the test barn as ‘specials’. More to follow.
