Proceedings of the Board of Stewards for the period of Monday, October 12, 2009 through Sunday, October 18, 2009. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

10/12/09 (1) Entries and Draw for Thursday 10/15/09

Entries were taken and a draw conducted for Thursday's card. At the 12:30 p.m. draw eighty-nine (89) head were drawn to compete in eleven (11) events.

10/12/09 (2) Dark Day

10/13/09 (1) Scratch Time for Thursday 10/15/09

At scratch time there were eight (8) driver corrections, two (2) claiming price corrections and one (1) injured scratch.

10/13/09 (2) Entries and Double Draw for Friday 10/16/09 & Saturday 10/17/09

Entries were taken and a double draw conducted for Friday's and Saturday's cards. At the 12:30 p.m. draw, one hundred twenty-six (126) horses were drawn to compete in fifteen (15) races on Friday's card. Immediately following, one hundred twenty-nine (129) head were drawn to compete in Saturday's fifteen (15) race card.

Scratch time for both cards is tomorrow at 9:00 a.m.

Scratch Time – Friday 10/16/09 and Saturday 10/17/09

At scratch time for Friday's card there were eleven (11) driver corrections and no other changes.

At scratch time for Saturday's card there were twenty seven (27) driver corrections and one (1) injured scratch.

"Super High 5" Field Size Increase

Management and the horseman's organization have agreed on a plan to increase the field size to twelve (12) for the Eighth Race on each night's card. This race will be the basis for the "Super High 5" wager on each program.

Substantial Increase in Entries

With the arrival of several new and returning stables to the barn area (John Chappell, Larry Hastings, Quentin Schneider and Gretchen Smith), the number of horses in the box each day has risen substantially again, raising the possibility of a fourth racing day each week.

Qualifying Entries and Sheet

Entries were taken and a qualifying sheet produced for nine (9) qualifying races to be conducted this afternoon, commencing at 4:00 p.m.

10/15/09 (2)

Qualifying Races

Nine (9) qualifying races were held today under the supervision of Stewards Baker and Meyers. Of the fifty three (53) participants, forty (40) were successful in their qualifying efforts.

10/15/09 (3)

Camera and Timer Problems

In the wake of Tuesday's severe rainstorm, we experienced a litany of electric and other related problems.

The 1/2 mile timer was non operational for the qualifiers until the ninth event. The head-on in the stretch, the wide pan and the 1/4 pole shot were not available for races 1 through 3.

Plusmic management was notified of the problems by Steward Will Meyers. More to follow.

10/15/09 (4)

First Race – Slow Quarter

Driver Jason Ricco, the driver of #1 "Ciera Rose" was contacted by the stewards following the first race to seek an explanation for the exceedingly slow time of 35¹ in the second quarter while Driver Ricco was in control of the race. Driver Ricco could offer no viable explanation. Subsequently, Driver Ricco was ordered to film review.

10/15/09 (5) **Fourth Race – Inquiry/Disqualification**

The stewards posted the ‘inquiry sign’ to investigate an incident approaching the 3/4 mile marker when #6 “The Godfather” (Luke Plano), who was leading the race, appeared to spot a leaf on the track and slowed and stepped to the right, causing confusion among the trailing horses and caused them to take evasive action.

After reviewing film and speaking to the drivers involved, the stewards unanimously concluded that #6, the eventual second (2nd) place finisher, had cost the remainder of the field ‘a chance at a better placing’. Thus #6 was disqualified and placed last. Driver Luke Plano was held blameless in the incident.

10/15/09 (6) **Eleventh Race – Inquiry/No Change**

The stewards posted the ‘inquiry’ to investigate an incident prior to the finish when #1 “Charmer” (James Kennedy), while on the lead and under strong urging, broke stride and continued offstride through the finish while finishing second (2nd).

After reviewing film, the stewards unanimously concluded that #1 “Charmer”, who had a commanding lead prior to breaking stride, had complied with the breaking rule, thus no change. Driver James Kennedy was ordered to film review.

Saturday10/17/09 (1) **Kennedy Ruling****Ruling # 13**

Driver James Kennedy, who drove "Charmer" in the Eleventh Race on Thursday, October 15, 2009, is hereby fined the sum of Three Hundred (\$300) Dollars for violation of California Horse Racing Board Rule #1734 (Whipping – No Driver Shall Use Unreasonable or Unnecessary Force in the Whipping of a Horse).

The above ruling was issued after Kennedy appeared and reviewed the race in question. "Charmer" was 4 or 5 lengths in front, down the stretch and Kennedy was overly aggressive with his whip, which in the steward's opinion, caused his mount to break stride and end up second. Kennedy understood and accepted the penalty.

10/17/09 (2) **Hernandez Review – 15th Race**

Driver/Trainer Chris Hernandez was in to review his drive aboard #3 "On Eagles Wings" in last night's 15th Race. Hernandez also trained eventual winner #4 "Quick On My Feet". Hernandez's horse tires in the stretch and it appears Hernandez becomes more concerned where his other horse is rather than paying attention to his own mount. He looks around continuously down the stretch rather than drive his horse. No interference occurred, but Hernandez drove carelessly. Disposition to follow.
