Proceedings of the Board of Stewards for the period of Monday, September 22, 2008 through Sunday, September 28, 2008. Steward Grant Baker was the Reporting and Duty Steward for the enclosed period.

#### Entry Day

Racing Secretary Fred Kuebler and his staff were on duty this morning taking entries for Thursday, September 25<sup>th</sup>. A total of nine (9) races filled. Seventy two (72) horses are scheduled to go to post.

#### Entry Day/Scratches

Scratch time was held at 9:00 a.m. today for Thursday, September 25<sup>th</sup>. Eleven (11) driver changes took place with no scratches submitted.

Entries were taken this morning for Friday, September 26<sup>th</sup>. Twelve (12) races were drawn and eighty three (83) horses are scheduled to face Starter Bill Vallandingham.

09/24/08 (1) **Entry Day/Scratches**

Scratch time was held at 9:00 a.m. today for Friday, September 26<sup>th</sup>. Three (3) driver changes took place with no scratches submitted.

Entries were taken this morning for Saturday, September 27<sup>th</sup>. Thirteen (13) races were drawn with one hundred three (103) horses scheduled to start.

**Thursday**

09/25/08 (1) **Scratch Time**

Scratch time for Saturday, September 27<sup>th</sup> was held this morning at 9:00 a.m. Five (5) driver changes were submitted before the deadline.

09/25/08 (2) **David Siegel Hearing**

Driver/Trainer Rocky Stidham appeared in the racing office as a representative of Driver David Siegel. Driver Siegel was ordered to see the stewards after his drive behind #8 “Jill’s Sooter”, who finished fourth (4<sup>th</sup>) in the seventh race September 20<sup>th</sup>.

Driver Siegel shifted his charge out in front of eventual winner #3 “Nikoleta” (James Kennedy). This incident took place 3/16ths of a mile before the finish and forced Driver Kennedy to quickly shift off the wheels of #8 “Jill’s Sooter before racing on to victory.

Representative Stidham passed along word from Driver Siegel that he (Siegel) accepted full responsibility for his driving error. The majority of the stewards (Steward Oke dissenting – 3 day suspension) felt the penalty in the ruling below was warranted.

**Ruling # 05**

*Driver David Siegel, who drove #8 “Jill’s Sooter” in the Seventh Race at Cal-Expo on Saturday, September 20, 2008, is hereby fined the sum of Two Hundred (\$200) Dollars for violation of California Horse Racing Board Rule #1721(J) (Driving Rules – Changing Course in the Stretch - Interfering with #3 “Nikoleta”).*

09/25/08 (3) **Rocky Stidham Ruling**

Driver Rocky Stidham appeared as ordered to review his drive behind #2 “SA Sunset”, who finished second (2<sup>nd</sup>) in the eleventh race last Saturday, September 20<sup>th</sup>. Driver Stidham survived a steward’s inquiry after racing inside a track pylon on the final (3/4 pole) turn. Driver Stidham accepted responsibility for his error in steering and the stewards issued the following ruling:

**Ruling # 06**

*Driver Rocky Stidham, who drove #8 “SA Sunset” in the Eleventh Race at Cal-Expo on Saturday, September 20, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1721(K) (Driving Rules – Careless Driving – Racing Inside Pylon – Last Turn).*

09/25/08 (4) **Tote Delay**

Payoffs for the third race were delayed for eight (8) to ten (10) minutes. Scientific Games Tote Operator Michelle Arendt notified the stewards that a total of Sixty One (\$61) Dollars in a Nevada superfecta pool was part of the problem.

The technicalities of this delay are included in a letter submitted with these minutes from Ted Shaine (Scientific Games).

09/25/08 (5) **Seventh Race – Inquiry**

The stewards posted the inquiry sign following this race to review an incident between sixth (6<sup>th</sup>) place finisher #1 “Jen U Win BB (Rocky Stidham) and seventh (last) place finisher #5 “Sin Princess” (Jason Maier).

Race replays show Driver Maier drop his right driving line while closing slightly in mid-stretch. At this point the right wheel of his sulky hooks wheels with #1 “Jen U Win BB”. No change was made in the order of finish as the offending horse in this matter (#5 “Sin Princess) finished last. Driver Jason Maier was ordered to film review with the stewards.

09/25/08 (6) **Eighth Race – Inquiry**

The stewards posted the inquiry sign following this race to review an incident entering the first turn. Ninth (last) place finisher #6 “Special Season” (James Lackey) went on a break on the first turn and contributed to some confusion with #7 “Linnea Blue Chip” (Lemoyne Svendsen), who went on to finish fifth. The stewards promptly removed the inquiry sign as no placings were necessary.

**Friday**09/26/08 (1) **Management Cutback**

In a cost saving effort, management at Cal Expo notified the receiving barn that all photocopied programs will now cost \$1.00.

For many years, programs have been provided free of charge to the private veterinarians in an effort to ensure that the vets have the needed post time information on horses to be compliant with California Horse Racing Board Rule #1845 (Authorized Bleeder Medications). In an effort to alleviate this issue, representatives of the CHHA (California Harness Horsemen's Association) have volunteered to provide programs at no cost.

09/26/08 (2) **Jason Ricco – Film Review**

The stewards held a film review with Driver Jason Ricco prior to the races this evening. Driver Ricco drove #1 "Pleasecashmybett", who finished third (3<sup>rd</sup>) in the sixth race last night (September 25<sup>th</sup>).

Driver Ricco's horse was significantly 'off the gate' prior to the start. At the opening night meeting with the drivers, the stewards stated that 'good starts' would be strictly enforced this meet. Driver Ricco was not pleased with the following sanction.

**Ruling # 07**

*Driver Jason Ricco, who drove #1 "Pleasecashmybett" in the Sixth Race at Cal-Expo on Thursday September 25, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1731(G) (Starting Rules – Failure to Come Up into Position).*

09/26/08 (3) **Jason Maier – Film Review**

Driver Jason Maier appeared in the steward's office to review his drive behind #5 "Sin Princess" in yesterday's (September 25<sup>th</sup>) seventh race. Driver Maier's horse hooked wheels with #1 "Jen U Win B B" (Rocky Stidham) in mid stretch after Driver Maier accidentally dropped an outside line. Driver Maier was issued a warning in this matter as he accepted full responsibility for the incident.

*Driver Robley Johnson, who drove #2 “Cam’s Gidget” in the Eighth Race at Cal-Expo on Thursday, September 25, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1731(G) (Starting Rules – Failure to Come Up into Position).*

Driver Robley Johnson accepted the ruling above after the stewards viewed “Cam’s Gidget” being ‘off the gate’ approximately four (4) lengths at the start.

09/27/08 (2) **Lou Pena Ruling****Ruling # 09**

*Driver Lou Pena, who drove #4 “Rojo Means Go” in the Eighth Race at Cal-Expo on Friday, September 26, 2008, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1731(G) (Starting Rules – Failure to Come Up into Position).*

Driver Lou Pena waived his right to a hearing and accepted the ruling listed above.

09/27/08 (3) **Leon Smith – Film Review**

Provisional Driver Leon Smith appeared in the steward’s office to review his drive behind #2 “Just Hunky Dory” in last night’s (September 26<sup>th</sup>) sixth race. This horse finished fifth (5<sup>th</sup>) and was whipped an excessive number of times in the opinion of the stewards. Whipping rules were reviewed with the drivers at an opening night (September 19<sup>th</sup>) driver’s meeting.

Driver Smith has had a clean driving record recently and accepted full responsibility before accepting the following penalty:

*Driver Leon Smith, who drove “Just Hunky Dory” in the Sixth Race on Friday, September 26, 2008, at Cal Expo, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1734) (Whipping – Unreasonable Use).*
