DFTD RULING #005

Jockey RICARDO JAIME is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Del Mar Race Track on November 11, 2018.

Jockey Agent RICHARD SILVERSTEIN is fined TWO HUNDRED DOLLARS (\$200.00)* pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations – failure to conduct business in a proper manner) on November 14, 2018 at Del Mar Race Track.

The following ruling was issued after Mr. Arroyo admitted he “spun” owner Nick Hines when he failed to honor a commitment to ride Empress Of Joy in the fourth race on Saturday the 17 of November.

DFTD RULING #007

Jockey Agent NELSON ARROYO is fined TWO HUNDRED DOLLARS (\$200.00)* pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations – failure to conduct business in a proper manner) on November 14, 2018 at Del Mar Race Track.

MARTIN RULING

After Mr. Martin failed to appear for the scheduled hearing on November 15, 2018, as stated in the following ruling his suspension will commence on November 23, 2018.

DMTD RULING #008

Owner MICHAEL MARTIN, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility – EQUINE MEDICAL & SURGICAL GROUP - \$2,016.60), is suspended on November 23, 2018 for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Michael Martin are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Martin is denied access to all premises in this jurisdiction.

All administrative hearings this morning were rescheduled, only regular issues were attended to.

STEWARDS' REVIEWS

Following the running of the second race the Stewards announced there would be a Stewards' Review to examine the actions of #4 Holly Blame (A. Quininez). Soon after the start the left rein either broke or became unbuckled. The outrider helped the rider pull the horse up near the 3/8 marker in the mile event. No other factors were involved, an inquiry was not necessary.

Following the running of the third race the Stewards announced there would be a Stewards' Review to review the actions of #4 Blame Joe (T. Baze). A few strides out of the gate jockey Baze pulled the horse up. A report was obtained from the track Veterinarian that the horse would be placed on the Veterinarians' List. Further inquiry was not necessary.

Following the running of the fourth race the Stewards announced there would be a Stewards' Review to witness the actions of #4 Uno Trouble Maker (T. Pereira), soon after the start crossing the chute in the six furlong event, the horse ducked in dramatically on its own. This incident did not require an inquiry.

VOIDED CLAIMS

After a physical examination by Official Veterinarian Will Farmer of #8 Blame Joe (Tr. P. Miller) in the third race, #2 Amers (Tr. J. Wong) and #6 Spectacular Move (Tr. S. HELLUM RULING CASE 16DM0063

Vendor Matt Unamuno (Angel's Feed) reported Lance Hellum has not complied with a financial agreement that was signed in 2016. Mr. Hellum was informed of the ruling issued below.

DMTD RULING #009

Owner/Trainer LANCE HELLUM, having failed to adhere to the terms of a financial agreement signed on December 30, 2016 is suspended on November 25, 2018 for violation of California Horse Racing Board Rule #1876 (Financial Responsibility – Angel's Feed Inc. - \$1,159.61).

During the term of suspension, all licenses and license privileges of Lance Hellum are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Lance Hellum is denied access to all premises in this jurisdiction.

DQ FORMAL HEARING CASE 18DM0077

The CHRB filed a complaint against owner Samantha Siegel (Jay Em Ess Stable) pursuant to CHRB rule 1859.5 (Disqualification Upon Positive Test Finding). Ms. Siegel and jockey, Joe Talamo are required by rule to return their earnings after a positive drug finding (procaine 2,932 ng/ml) in the horse Mr. Vargas who finished first in the seventh race at Del Mar Race Track on August 18, 2018. Neither licensee appeared for the hearing. Present before the BOS were CHRB Investigator Jim Hamilton and Court Reporter Michelle Derieg recorded the proceedings. The facts of the case were entered into evidence, the hearing was closed and the following ruling revising the order of finish was issued.

DMTD RULING #010

Acting on a report from the University of California, Maddy Analytical Laboratory, the official testing laboratory for the California Horse Racing Board, that urine sample #DM14398, obtained from the horse MR. VARGAS, the first place finisher in the seventh race at Del Mar Race Track on August 18, 2018, contained Procaine (Class 3) in excess of the permitted level (2,932 ng/ml), it is ordered that MR. VARGAS be disqualified from all purse monies earned and deemed unplaced in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$39,000.00) earned or awarded to Owner JAY EM ESS STABLE (\$34,843.00), and Jockey JOE TALAMO (\$3,900.00) to the Paymaster of Purses at Del Mar Race Track by December 18, 2018, for redistribution in accordance with the revised order of finish.

The revised order of finish is as follows:

- 1st GATO DEL ORO
- 2nd STONE HANDS
- 3rd ADENS DREAM
- 4th JAN'S RESERVE
- 5th DENMAN'S CALL

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1856 (Race Declared Official) neither pari-mutuel payoffs nor the distribution of any pari-mutuel pool shall be affected.
