RUBEN FUENTES FILM REVIEW

Jockey Ruben Fuentes appeared in the Stewards' Office to review his ride in the first race at Santa Anita Park on closing day Sunday, November 3. Jockey Fuentes was aboard #10 You Must Chill who finished third in this one (1) mile race contested on the infield turf course. Jockey Fuentes was involved in two (2) separate incidents in this race.

Incident #1- #10 You Must Chill lugged in at the 1/8th mile marker and put 'outside pressure' on two (2) rivals; forcing their jockeys to steady their mounts. Those horses were eighth place finisher #8 Tanker (Joseph Talamo) and ninth place finisher #7 Thin Line (Heriberto Figueroa).

Incident #2- Second place finisher #5 Red Clem (Geovanni Franco) steps out and makes contact with #10 You Must Chill in the final furlong of the stretch drive. #10 You Must Chill then drifts in and makes contact (3 times) with #5 Red Clem.

The Stewards told Jockey Fuentes he could have made a better (stronger) effort to keep his mount straight. He agreed. Due to the fact his horse was 'lugging in' in the stretch drive of this race, Jockey Fuentes was excused without being issued a penalty. The decision was unanimous.

11/09/18²**ANGEL CRUZ FILM REVIEW**

Jockey Agent Matt Nakatani called the Stewards' office and told the Stewards that his client, Jockey Angel Cruz would like to waive his right to a hearing this morning and plead guilty to a use of violation of CHRB Rule #1688 (Use of Riding Crop). Jockey Cruz rode #6 Jan's Reserve to a fourth place finish in the sixth race on November 4, 2018 which was closing day of their 2018 Autumn meeting. He used his riding crop five (5) times without giving his horse a chance to respond. In a unanimous decision the Stewards issued the following ruling.

DFTD RULING #001

Jockey ANGEL CRUZ is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Santa Anita Race Track on November 4, 2018.

11/09/18³**JOCKEYS ROOM MEETING**

The Stewards held a meeting at 11:30 p.m. with the Del Mar jockey colony in the jockey's room. Several topics were covered. At the recently concluded Santa Anita meet jockey's lodged objection's to the Stewards thru track outriders instead of a 'Quick Official' employee who has been employed at southern California racetracks for the last several years. Once again at Del Mar Larry Gilligan will be manning this position. Along with the Stewards, Clerk of Scales Matt Nichols and Track Veterinarian Dana Stead DVM spoke at our meeting.

11/09/18⁴**SECOND RACE INQUIRY**

The Stewards posted the Inquiry sign prior to conducting an investigation into the actions of five (5) horses at the start of this seven (7) furlong main track event. The actions of the following horses were reviewed.

#1 Eskenforadrink (1st Place-Heriberto Figueroa)

#2 Heloise (2nd Place-Luis Fuentes)

- #3 Trappiza (3rd Place-Ruben Fuentes)
- #4 Sweet Congrats (5th Place-Assael Espinoza)
- #5 Irish Lassie (6th Place-Evin Roman)

Replay review shows #1 Eskenforadrink break outward. #2 Heloise was off slowly. #3 Trappiza was pinched back from between horses after receiving 'pressure' from rivals to the inside and outside of her. #4 Sweet Congrats stumbled and was bumped at the start. #5 Irish Lassie broke inward.

The Stewards spoke to the riders of the first three (3) finishers and received a patrol judge report. Due to the multiple factors listed above the Stewards, in a unanimous decision, made no change in the order of finish.

11/09/18⁵

SIXTH RACE ACCIDENT/ INQUIRY

The Stewards posted the Inquiry sign after viewing an incident at the start of this 5 ½ furlong main track event. #7 Big Barrel (Alonso Quinonez) stumbled and lost his rider about two (2) strides after the start. #7 Big Barrel was captured by one of the track outriders during the race. Jockey Alonso Quinonez was attended to by track paramedics. It was reported that he was transported to a local hospital. Safety Steward Paul Atkinson will prepare an accident report that will be attached to our minutes. This single horse incident as caused by the actions of #7 Big Barrel. Following film review this race was declared 'official'.

11/09/18⁶

SEVENTH RACE INQUIRY

The Stewards posted the Inquiry sign following the running of the Kathryn Crosby Stakes (Purse \$75,000 Added) which was contested at one (1) mile on the Jimmy Durante Turf Course. The purpose of the Inquiry was to investigate an incident at approximately the 1/16th mile marker. At this point of the race the leader and eventual first place finisher #4 Excellent Sunset (IRE) drifts in and takes the path of original second place finisher #9 Escape Clause (Ruben Fuentes). This action forced Jockey Fuentes to steady his mount and lose momentum which he eventually regained before being beaten a ½ length margin at the finish line.

The Stewards spoke to both jockeys involved and received a patrol judge report. The Stewards reviewed all camera angles of the incident. The Stewards unanimously ruled that this incident afforded #9 Escape Clause an opportunity for a better placing. #4 Excellent Sunset (IRE) was disqualified and placed second. Jockey Mario Gutierrez was ordered to film review with the Stewards.

PETER MILLER COMPLAINT (CASE NO. LT0016)

The complaint in this matter reads as follows.

Trainer Peter Miller is indebted to hot walker Michael Embelton for wages. Total \$723.13. See report of investigation.

This hearing was originally scheduled for October 13, 2018 at Santa Anita Park. Michael Embelton requested a continuance from the Stewards and today was the new hearing date. Peter Miller sent Assistant Trainer Ruben Alvarado to represent him today. Mr. Embelton did not appear at today's hearing and this case was subsequently dismissed.

MARIO GUTIERREZ FILM REVIEW (REF: 11/09/18 (6))

Valet Ozzie Ayala appeared in the Stewards' Office in order to represent Jockey Mario Gutierrez at a film review. Jockey Gutierrez was out of town today for personal reasons. We gathered here today to review the actions of #4 Excellent Sunset (IRE) (Mario Gutierrez) who finished first but was disqualified and place second for stretch interference in the one (1) mile turf, Kathryn Crosby Stakes (\$75,000 Added).

Film review today shows Jockey Gutierrez and #4 Excellent Sunset (IRE) drift in at mid-stretch. This horse was already drifting in when Jockey Gutierrez struck this horse with his riding crop (right-handed). This action, which the Stewards eventually determined to be careless, caused second place finisher #9 Escape Clause (Ruben Fuentes) to steady his mount sharply and nearly clip the heels of Jockey Gutierrez' mount. In a unanimous decision the Stewards issued the following sanction in ruling form.

DFTD RULING #002

Jockey MARIO GUTIERREZ, who rode EXCELLENT SUNSET (IRE) in the seventh race at Del Mar Race Track on November 9, 2018 is suspended for THREE (3) racing days (November 17, 18 and 22, 2018) for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from first to second position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – Careless Riding).

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

JAMES CHAPMAN COMPLAINT (CASE NO. 18SA0208)

Private Veterinarian Melinda Blue filed a complaint against Trainer James Chapman for alleged non-payment of a veterinarian bill in the amount of \$1,388.98. Mr. Chapman was not present today. The Stewards spoke to him on the telephone today as he still owes DVM Blue \$500 of the total amount. He told the Stewards he would pay via credit card by tomorrow. (November 12, 2018).

11/11/18²**GEOVANNI FRANCO FILM REVIEW**

Jockey Giovanni Franco appeared in the Stewards office in order to review his ride in yesterday's (November 11) seventh race. (Let It Ride Stakes - \$75,000 Added). Jockey Franco was aboard #7 Calexman who finished third in this one (1) mile event contested on the Jimmy Durante Turf Course.

Film review today shows #7 Calexman in front, before entering the stretch. Just before straightening out for his stretch run Jockey Franco strikes his horse with his riding crop (left-handed). His mount shifts out into the path of eventual seventh place finisher #1 Afleet Ascent (Kent Desormeaux) forcing that rival to steady from between horses. The majority of Stewards voted to issue a warning. Steward Baker dissented voting for a careless riding suspension.

11/11/18³**MAURO DONOE FILM REVIEW**

Jockey Mauro Donoe appeared in the Stewards' Office to review his ride in the sixth race which was contested at 6 ½ furlongs on the main track. Film review this morning shows Jockey Donoe use his riding crop four (4) consecutive times aboard the tiring

ninth place finisher #1 Dressed in Prada. This is Jockey Donoe's second violation of CHRB Rule #1688 in the last sixty (60) days. In a unanimous decision the following ruling was issued.

DFTD RULING #003

Apprentice Jockey MAURO V. DONOE, is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board rule #1688 (b) (6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – second offense in the last sixty days), during the sixth race at Del Mar Race Track on November 10, 2018.

11/11/18⁴

NEW JOCKEY

New Apprentice Jockey Humberto Tellez appeared in the Stewards office to get his apprentice certificate from the Stewards. The twenty-seven (27) year old Tellez has worked as an Exercise Rider for Keith Desormeaux for approximately five (5) years. Safety Steward Paul Atkinson was also present. Mr. Atkinson and the Stewards reviewed many items with Apprentice Tellez. He finished seventh in today's sixth race aboard #1 Fleetwood following a good 'heads up' ride on a day he should never forget.

FOURTH RACE ACCIDENT/ INQUIRY

The Stewards posted the Inquiry sign following this race to review the start which was contested at the distance of 6 ½ furlongs on the main track. #3 Wild Verse (Heriberto Figueroa) stumbled badly immediately after the start. Apprentice Figueroa acrobatically tried to regain his seat in the saddle before this three (3) year old gelding jumped up and over the inside rail unseating Apprentice Figueroa. #3 Wild Verse temporarily ran loose in the stable area before being captured. Apprentice Figueroa was cleared after being examined in first aid. "Wild Verse" had some abrasions on his legs and otherwise was reported to be in good condition.

The Stewards were informed today that the financial complaint (CASE NO.18SA0208) made by Melinda Blue DVM against Trainer James Chapman has been paid in full. This matter has now been dismissed.

KENT DESORMEAUX RULING

Jockey Kent Desormeaux was scheduled to appear in the Stewards' office before he waived his right to an informal hearing and accepted the decision listed in ruling form below. The Stewards observed Jockey Desormeaux striking his horses' ear in the stretch of a one (1) mile main track event yesterday (November 11). Jockey Desormeaux was aboard first place finisher #7 Dancing Belle.

DFTD RULING #004

Jockey KENT DESORMEAUX is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop – Misuse) during the second race at Del Mar Race Track on November 11, 2018.

11/12/18³

THIRD RACE INQUIRY/JOCKEYS OBJECTION

The Stewards posted the Inquiry sign following this race to investigate the actions of first place finisher #7 Buckstopper Kit (Kent Desormeaux), second place finisher #2 Flip the Coin Jan (Heriberto Figueroa) and third place finisher #1 Zestful (Rafael Bejerano). Jockey Bejerano who rode third place finisher #1 Zestful also lodged a jockey's objection against second place finisher #2 Flip the Coin Jan for alleged interference in the stretch of this one (1) mile race contested on the Jimmy Durante Course (turf).

Initial race replays showed that first place finisher #7 Buckstopper Kit was not involved with any interference. Films show #2 Flip the Coin Jan drift out in the final furlong of this race. #1 Zestful steadies his mount when he 'races up' on the heels of #2 'Flip the Coin'. The Stewards received a patrol judge report and spoke to all 3 jockeys' whose numbers were flashing on the tote board. After reviewing the films the Stewards ruled that while clearance was marginally sufficient this incident did not rise to the level of a disqualification. In a unanimous decision 'no change' was made in the order of finish. Apprentice Jockey Figueroa is ordered to film review with the Stewards.

ATTENDANCE REPORT – A full Board of Stewards was in session each day during this Reporting period for both morning business and the afternoon racing program.
