07/27/14<sup>1</sup> **TURF MEETING (REF -07-26-14 (4))**

Medical Equine Director Dr. Rick Arthur, Exec.V.P. Tom Robbins, Exec.V.P. Josh Rubinstein, Racing Veterinarian Dana Stead, Safety Steward David Nuesch and Track Superintendent Leif Dickinson met with the BOS to discuss the condition of the turf course after the two breakdowns on the turf course yesterday. It was Del Mar Management's decision to change the two turf races today scheduled to run at 1 1/16 and run them the same distance on the polytrack surface (fifth and eighth races). All exchanged questions and answers. Leif Dickinson explained his treatment to the turf course last night before and after an unexpected rainfall, which caused a change to his original plan to soften the course. Mr. Dickinson and the CHRB Track Safety Stewards will test the turf course on Monday and Tuesday, with their own equipment. More to follow.

Jockey Kent Desormeaux, as directed met with the BOS to review the fourth race yesterday. Approaching the main course coming out of the chute in the seven-furlong event, Mr. Desormeaux's mount ducked in sharply, tightening the space

on the horses to his inside. He explained that his filly saw the gap and ducked inward trying to go left and cross onto the main course. The pan angle of the review verified that Mr. Desormeaux was telling the truth and was he excused without penalty.

Jockeys Corey Nakatani and Elvis Trujillo were placed on the board in the jockey quarters to meet with the stewards and review the fourth race. Mr. Nakatani, while easing his horse in the stretch, guided it to the outside, causing another horse to change its course to avoid him.

Mr. Trujillo, in the stretch run, allowed his mount to drift out slightly without correction squeezing a horse to his outside. Both riders admitted their mistakes and left the office with a warning.

**OROZCO HEARING CASE 14DM003**

The CHRB filed a complaint against jockey Irving Orozco for alleged violation of CHRB Rule 1872 (Failure to Fulfill Jockey Agreement). Representing the CHRB was Supervising Investigator Rick Amieva. Mr. Orozco on July 11, 2014 was removed from the jockey quarters at Los Alamitos on a warrant issued by West Covina Court House. Mr. Orozco was unavailable to ride July 12 as well, missing four mounts at Los Alamitos and one mount at Del Mar yesterday. The following ruling was issued.

**RULING DMTD #007**

Jockey IRVING OROZCO is fined ONE THOUSAND DOLLARS (\$1,000.00)\* for failure to fulfill his riding engagements at Los Alamitos Race Track and Del Mar Race Track on July 11, 12, and 31, 2014. This constitutes a violation of California Horse Racing Board Rule #1872 (Failure to Fulfill Jockey Agreement).

**TRAINER OBJECTION NO CHANGE (5<sup>th</sup> race ¾ poly)**

Following the running of the race trainer Mike Pender of #6 Test Ride who finished second lodged a claim of foul against the winner #2 Shakahari (R. Bejarano). After a review of the video angles, conversation with the Patrol Judges and both jockeys it was a unanimous decision to let the original order of finish stand. It was the opinion of the BOS both horses did float down the stretch with a horse path between them and there was no infraction.

Following the running of the race the inquiry sign was posted to review an incident when #6 Serious (Tr. V. Smith) went wrong and was pulled up by jockey Francisco Duran. After reviewing the videos it was a unanimous decision to make the original order of finish official. There were no other horses involved in the incident.

During the term of suspension, all licenses and license privileges of BRYAN CONWAY are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards to Suspended or Fine), Mr. CONWAY is denied access to all premises in this jurisdiction.

**COUTON RULING**

The following ruling was issued after Mr. Couton met with the Stewards to review the fourth race yesterday. Jockey Guild Representative Darrell Haire was present for the review. On the second turn of the mile turf event Mr. Couton, on the outside of a three horse spread allowed his horse to step in causing the two horses to his inside to bump, hit the fence and take up. The decision for the penalty was unanimous.

**RULING DMTD # 010**

Jockey JULIEN COUTON is suspended for THREE (3) racing days (August 7, 8, and 9, 2014) for crossing over without sufficient clearance and causing interference while riding Awesome Diamond in the fourth race at Del Mar Race Track on July 31, 2014. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board Rule #1766 (Designated Races).

Present at the hearing before the BOS were Guild Representative Darrell Haire, Winner's Foundation Representative Leroy Martinez, jockey agent R. C. Ebanks, representing the CHRB, Rick Amieva and court reporter Michelle Derieg documented the proceedings. There was much dialog concerning Mr. Flores' history with drugs (illegal, prescription and alcohol) and penalties that could be implemented for missing mounts and not drug testing when ordered to do so. After the BOS receives recommendations from Winner's Foundation a decision will be made in ruling form.

According to CHRB rule 1843.3 category "D" penalty guidelines, Mr. Kitchingman is eligible for and received a warning.
