AGUIRRE RULING

The following ruling was issued after the CHRB adopted the proposed decision, it was remanded back to the BOS to issue a ruling and order the dates of suspension and the payment of a fine. Mr. Aguirre met with the Stewards to discuss the issuance of the penalty.

RULING #050

Acting on an order of remand from the California Horse Racing Board, trainer **PAUL AGUIRRE**, who started the horse DUGAN BILL in the seventh race at Betfair Hollywood Park on November 8, 2012, is fined **FIVE HUNDRED DOLLARS (\$500.00)*** and suspended for **FIFTEEN (15) DAYS** (September 3rd through September 17th, 2013) for violation of California Horse Board rule #1843(a)(d) (Medication, Drugs and Other Substances – carisoprodol and meprobamate – class 2, penalty category B) pursuant to California Horse Racing Board rule #1887(a) (Trainer to Insure Condition of Horse).

During the term of suspension, all licenses and license privileges of Paul Aguirre are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Aguirre is denied access to all premises in this jurisdiction.

NICOLAS RULING

The following ruling was issued after Mr. Nicolas met with the Stewards to review the eighth race (5½ poly) yesterday. Mr. Nicolas during the run down the backstretch, passed two horses, veered inward, causing those two horses on his inside to take up sharply. He was candid in admitting his error and said he would be more aware in the future.

RULING #051

Apprentice jockey **GONZALO NICOLAS** is suspended for **THREE (3) RACING DAYS** (September 4, 27 and 28, 2013) for altering course without sufficient clearance and causing interference while riding Magic Number in the eighth race at Del Mar Thoroughbred Club on August 28, 2013. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

After the finish of the race the Inquiry sign was posted to review an incident at the start involving #1 Marina Del Heat who stumbled at the start and unseated jockey Chantal Sutherland-Kruse. Mr. Valenzuela finally accepted responsibility for not being within the limits of the weight he reported one hour before the first race.

Jockey **PATRICK VALENZUELA** is fined **FOUR HUNDRED DOLLARS (\$400.00)*** for failure to make his assigned weight in the sixth race at Del Mar Thoroughbred Club on August 29, 2013. This constitutes a violation of California Horse Racing Board rule #1682 (Weighing Out- 3rd offense).

INQUIRY NO CHANGE SIXTH RACE (1mile poly)

Following the running of the race the Inquiry sign was posted to review an incident approaching the quarter pole. Involved were #1 R S Watson (V. Espinoza 7th), #4 Fury Kapcori (R. Bejarano 2nd) and #8 Holy Lute (D. Flores 1st). After talking with the Patrol Judges and all jockeys involved it was a unanimous decision to let the original order of finish stand. The #1 horse, while losing his momentum, had to check when the #8 shifted out to pass a horse in front of him and #4 leaned in to hold his line. The Stewards believed that, #1's placing was not affected.
