KORINER RULING

Pursuant to the gelding hearing referenced last Sunday, we issued the following ruling against trainer BRIAN KORINER:

DMTD #022

Trainer **BRIAN KORINER** is fined **SEVEN HUNDRED FIFTY DOLLARS (\$750.00)*** for failure to properly report the gelding of the horse "ST MARINO", which ran in the fifth race at Hollywood Park Race Track on July 4, 2011. This constitutes a violation of California Horse Racing Board rule #1865(Altering of Sex of Horse).

VAN BERG RULING

Pursuant to the hearing involving a complaint filed against trainer JACK VAN BERG for a flunixin positive, we issued the following ruling:

DMTD #023

Trainer **JACK VAN BERG**, who started the horse "WARREN'S KONG" in the third race at Hollywood Park Race Track on July 8, 2011, is fined **FIVE HUNDRED DOLLARS (\$500.00)*** pursuant to California Horse Racing Board rule #1887(Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1844(c)(2)(Authorized Medication-Flunixin in excess of permitted level).

FILM REVIEW

Jockey **CHANTAL SUTHERLAND** came to the office this morning to review her ride in the first race on August 6, 2011. Her horse was the subject of an inquiry via a trainer's objection. Films revealed that she actually interfered with two horses during the stretch run. The first incident could be blamed on the horse but the second incident involved Ms. Sutherland's mount drifting out under left handed urging and interfering with the eventual winner. We voted unanimously to issue three suspension days for the careless riding. This was memorialized in the following ruling:

DMTD # 025

Jockey **CHANTAL SUTHERLAND** is suspended for **THREE RACING DAYS** (August 20, 21 and 24, 2011) for failure to make the proper effort to maintain a straight course in the stretch, causing interference while riding "Macho Dorado" in the first race at Del Mar Thoroughbred Club on August 6, 2011. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

INQUIRY/NO CHANGE

We put up the inquiry sign to examine an incident at the start of the tenth race. To wit, #6 Magic Mama, with Rafael Bejarano in the irons, reared up as the gates opened, the assistant starter released the horse appropriately, and her jockey stepped off her back in order to avoid being dumped out the back of the gate. Since #6 Magic Mama caused her own problems, she was declared a starter and there was no need for a disqualification or refunds.

O'RILEY HEARING

We held a formal hearing this morning into a complaint filed by the CHRB against assistant to veterinarian MICHAEL O'RILEY alleging violation of CHRB rules 1930 and 1530. This action stems from an incident with Official veterinarian Dr. Jill Bailey, who advised Mr. O'Riley that he was not permitted to massage horses that were running that day. Subsequent to that warning, Mr. O'Riley was allegedly massaging a horse in the morning that was running later in the afternoon of July 20, 2011. That action produced this complaint. Representing the CHRB was investigator Rick Amieva, representing Mr. O'Riley was attorney Clay Sides. Dr. Bailey was called as a witness and Barbara Weinstein recorded the proceedings. Documentary and oral evidence was taken, legal arguments and the record was closed. Decision to follow.

We posted the inquiry sign after the running of the seventh race to examine the start involving #5 Linda Lou, ridden by Joel Rosario. Films revealed that the mare was acting badly in the starting gate and then when the gates opened, reared up. While Mr. Rosario managed to stay on, but his mount broke very slowly. We unanimously voted to make no change to the order of finish.

FILM REVIEW

Jockey ANTONIO CASTANON was called in to review his ride in the third race yesterday in which we believed that he was maintaining a bad position going into the first turn. While it took some convincing, he eventually saw our point of view and agreed to be more proactive in the future.

Apprentice jockey ESWAN FLORES came to the office to review his ride in the same race. Films revealed that he put some pressure on the horses to his inside going into the first turn. While he initially wanted to blame other riders, but after reviewing the films he understood that as the outside rider, he was the only one that could relieve the pressure.

Jockey PATRICK VALENZUELA came to the office to review his ride in the seventh race yesterday during which, he allowed his mount to drift in the stretch. He acknowledged his mistake and pledged to be more vigilant in the future.

Jockey JOSE VERENZUELA came to this office to review his ride in the last race on Saturday. While his mount and Patrick Valenzuela's mount were leaning on each other throughout the stretch, Mr. Verenzuela pushed harder the last couple of strides. We explained that while he was only partly to blame for the contact, it is always best to maintain a straight course in order to avoid disqualification and suspension days.

Jockey BRICE BLANC came to the office to examine his ride in the first race yesterday. Films revealed that around the turn, he angles his mount out and interferes with the horse to his outside, sending that rival over heels. Mr. Blanc acknowledged the interference but blamed a horse stopping in front of him and stepping out for causing the trouble. Steward Sawyer agreed with his reasoning, but the majority voted for a three day suspension:

DMTD # 027

Jockey **BRICE BLANC** is suspended for **THREE RACING DAYS** (August 18, 19 and 20, 2011) for altering course without sufficient clearance near the five sixteenth's pole and causing interference while riding "Thunder Canyon" in the first race at Del Mar on August 11, 2011. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).
