JULY 13, 2008

1 DOUBLE ENTRIES

Steward RANDY WINICK was at the racing office today to oversee entries for both Wednesday and Thursday. The day proceeded without incident.

MONDAY
JULY 14, 2008

1 ENTRY DAY

Steward RANDY WINICK was again present at Del Mar for entries for Friday.

TUESDAY
JULY 15, 2008

1 SCRATCHES

Steward RANDY WINICK took scratches for opening day.

2 PRE-MEET MEETING

A pre-meet meeting was held this afternoon to discuss the imminent Del Mar meeting. In attendance were Tom Ward (Steward), Randy Winick (Steward), Scott Chaney (Steward), Luis Jauregui (Assistant Steward), Joe Harper (President DMTC), Craig Fravel (Vice President DMTC), Dr. Rick Arthur (Equine Medical Director, CHRB), Kristin Whitley (TCO2 tester), Bill Westermann (CHRB Supervising Investigator), Bill Sullivan (Director of Security), Sam Templeton (Backside Security), Jim Young (Security – surveillance), Ron Charles (Santa Anita), Dr. Jill Bailey (Racing Veterinarian), Dr. Tim Connor (Official Veterinarian), Drew Couto (TOC), Ed Halpern (CTT), Darrell Haire (Jockey's Guild), Tom Robbins (Director of Racing), Rick Hammerle (Asst. Racing Secretary), Steve Woods (Track Superintendent), and Francisco Gonzalez (CHRB Auditor). Issues discussed included, but were not limited to, the new synthetic surface, morning soundness inspections, the new steroid rules, also-eligible procedures, scratching procedures, and horse ambulance protocol. Management also reiterated their concern for the safety of the horse, and explained that the examining veterinarians should always err on the side of protecting the animal when deciding whether to scratch a horse or not.

WEDNESDAY
JULY 16, 2008

1 OPENING DAY

Today marks the opening day of 43 days of racing at Del Mar and the sixty-ninth season of racing. As always, with more than 40, 000 fans expected, things were a bit hectic this morning, but true to form, DMTC is always prepared and diligent in solving any issues that arise.

2 MEETING WITH JOCKEYS

The Board of Stewards met with the jockey colony today, prior to the races, in order to review our expectations for the upcoming meeting. Historically, Del Mar has been challenging for riders in terms of the high number of inquiries, disqualifications and riding suspensions. We alerted the riders to this fact and requested that they take care of one another on the track—emphasizing safety and fairness as our highest priority.

3 OBJECTION/NO CHANGE

Following the running of the fourth race, jockey Joe Talamo, aboard fifth place finisher #4 Ron Bob claimed foul against the winner for interference in mid-stretch on the turf course. The winner (in a dead heat) #6 I'm in the Mood appears to drift out and cause Mr. Talamo to steady and break stride. After speaking with the patrol judges and riders involved, the stewards unanimously voted to make no change. In our opinion, although #4 Ron Bob did steady, he did not lose the opportunity at a better placing.

4 OBJECTION/NO CHANGE

After the running of the seventh race, jockey Victor Espinosa, aboard eighth place finisher #1 Adobe Hacienda, claimed foul against the winner, #3 Perfect Cast ridden by Rafael Bejarano, for interference turning for home on the synthetic surface. Films revealed that the winner does cross in front of Mr. Espinosa's mount, causing him to steady briefly. However, after speaking with the patrol judges and riders involved, stewards unanimously voted to make no change to the original order of finish. In our opinion, Mr. Espinosa's mount was not cost the opportunity at a better placing.

5 INQUIRY/NO CHANGE

After the running of the eighth race, the stewards posted the inquiry sign to examine the stretch run. Specifically, we were looking at two incidents. The first occurred when the winner #3 Dixie Chatter, ridden by Richard Migliore drifted out causing the second and third place finishers to drift out as well. After reviewing the films, and speaking with the riders and patrol judges, it was our unanimous opinion that the drift did not constitute interference and therefore no change was appropriate. Secondly, we examined an incident in which the second place finisher, #6 Mr. Keppel (IRE), ridden by Isaias Enriquez, who drifts in and causes third place finisher #1 Liberian Freighter to steady. After reviewing the films, it was our opinion that the space between horses closed after the wire and that therefore no change was required.

THURSDAY
JULY 17, 2008

1 FILM REVIEW

Jockey ISAIAS ENRIQUEZ met with the stewards regarding his ride in the eighth race yesterday in which his mount drifts in when approaching and after the wire. While he does cause David Flores to check his mount, the lion's share of the drift occurred at and past the wire. Although this could be dangerous, we didn't feel that suspension days were appropriate.

Jockey TYLER BAZE met with the stewards to review his ride in the fourth race yesterday in which his mount drifts out during the stretch run on the turf, placing fellow rider Joe Talamo in a difficult position. While Mr. Baze did make some effort to correct this drift, we explained that a far better effort needs to be demonstrated to escape days in the future.

Jockey RICHARD MIGLIORE met with the stewards regarding his ride in the eighth race yesterday, which was the subject of an inquiry. Mr. Migliore's mount drifts out, causing the two horses to his outside to alter path as well. While we did not feel that this constituted interference nor, by extension, careless riding, we did caution Mr. Migliore that he was very close to the line.

Jockey RAFAEL BEJARANO met with the stewards to discuss his ride in the seventh race yesterday in which his mount crosses in front of a rival ridden by Victor Espinosa, as the field is straightening away in the stretch. Mr. Espinosa's mount is tiring, but the stewards cautioned Mr. Bejarano that he does not need to cut these actions so close but instead wait an extra stride before altering course. He agreed.

2 CARAVA RULING

Trainer JACK CARAVA contacted the stewards by telephone to discuss case 08HP055, which alleged Phenylbutazone in excess of the permitted level. Mr. Carava did not have an explanation for the overage, but accepted the following penalty without objection:

DMTD Ruling #1

Trainer Jack Carava, who started the horse "Gold Trim", the second place finisher in the fourth race at Hollywood Park on June 8, 2008, is fined four hundred dollars (\$400.00)* pursuant to California Horse Racing Board rule # 1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs, and Other Substances – Phenylbutazone in excess of permitted level).

3 KRULJAC HEARING

Trainer ERIC KRULJAC met with the stewards in an informal hearing to discuss case 08HP062 which involved a horse listed in the program as a gelding, which was actually a colt. Apparently the racing office received information that this horse was a gelding at some point prior to entry—a claim that

Mr. Kruljac disputes. The entry card also showed that Mr. Kruljac entered the horse as a colt. For these reasons, the stewards voted to dismiss the complaint.

4 CANANI HEARING

Two former employees of trainer NICK CANANI appeared at the stewards' office regarding case number 08HP057 which involved alleged unpaid wages. Mr. Canani did not appear. The stewards will attempt to contact Mr. Canani before issuing a suspension ruling for failure to appear.

5 MEETING WITH JOCKEYS

This Board of Stewards, disappointed with the quality of riding on opening day, decided to have a second meeting with the riding colony to explain that this type of behavior would not be permitted. In no uncertain terms did we admonish them that careless riding would result in suspension days in order to promote the twin goals of safety and fairness.

1 TWILIGHT RACING

On this first Friday of racing, all matters were routine.

2 DOMINGUEZ RULING

Trainer CAESAR DOMINGUEZ contacted the stewards by telephone to discuss case 08HP0052 which alleged a high bute after a workout for removal from the vet's list. Mr. Dominguez, though unaware of the rule allowing penalties with respect to morning works, accepted the penalty without objection:

DMTD Ruling #2

Trainer Caesar Dominguez, who worked the horse "Seven Lucky J's" at Santa Anita Park on June 6, 2008, to be removed from Vets list, is fined four hundred dollars (\$400.00)* pursuant to California Horse Racing Board rule # 1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs, and Other Substances – Phenylbutazone in excess of permitted level).

3 OBJECTION/NO CHANGE

Following the running of the third race, apprentice jockey Jose Campos, who rode third place finisher #7 Heaven Tonight, claimed foul against the second place finisher #6 Miss Lydia, ridden by Martin Pedroza, for interference down the backside. After reviewing the films and speaking with the patrol judges and riders involved, the stewards unanimously decided to make no change to the original order of finish. In our opinion, Mr. Pedroza's mount does drift out a bit, but not nearly enough to constitute interference.

1 PENDER RULING

The following ruling was published after speaking with trainer MIKE PENDER about his horse that arrived in the receiving barn for last night's sixth race with turn downs for a turf race. After unsuccessful attempts to file them down to comply with the rule, Mr. Pender's horse was scratched. He accepted this ruling without objection:

DMTD Ruling #3

Trainer MIKE PENDER is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule # 1853 (Examination Required – improperly shod for turf) resulting in the late declaration of his horse NIMA'S PAD from the sixth race on July 18, 2008.

2 INQUIRY/DISQUALIFICATION

Following the running of the fifth race today, the stewards posted the inquiry sign to examine an incident at the quarter pole in which third place finisher #8 It's Time to Shine, ridden by Michael Martinez, bears out sharply and makes solid contact with the fifth place finisher, #7 Continental Dancer, ridden by Gerardo Gavica. #7 Continental Dancer finishes one length behind the fourth place finisher. After speaking with the patrol judges and riders involved, the stewards unanimously voted to disqualify #8 It's Time to Share and place him fifth.

1 FILM REVIEW

Apprentice jockey MICHAEL MARTINEZ met with the stewards to discuss his ride in the fifth race yesterday in which his mount was disqualified for interference at the quarter pole. Mr. Martinez brought his cousin Alex Solis in to act as his translator/representative. Unfortunately, it was not enough to spare him days. In our opinion, Mr. Martinez could have been a much better effort to correct his mount when he shifted out turning for home.

DMTD Ruling #4

Apprentice Jockey MICHAEL MARTINEZ, who rode “IT’S TIME TO SHINE” in the fifth race at Del Mar Thoroughbred Club on Saturday, July 19, 2008 is suspended for three (3) racing days (July 27th, 28th and 30th, 2008) for altering course without sufficient clearance, causing interference which resulted in the disqualification of his mount from third to fifth position, which is a violation of California Horse Racing Board Rule # 1699 (Riding Rules – Careless Riding).

The terms of this suspension shall not prohibit participation in designated races in California.

Jockey JOSE CAMPOS met with the stewards to discuss his ride in the last race yesterday in which his horse drifts in throughout the lane. Although this was not the type of ride that warranted days, we wanted to caution Mr. Campos that a straight path will always keep him out of the stewards’ office.

Jockey MIKE SMITH met with the stewards to discuss his ride in the sixth race yesterday in which his mount drifts out slightly in the stretch, putting two rivals in difficult positions. Upon reviewing the films, it appears that Mr. Smith does make some effort to correct his mount and that he is influenced by another rival. Nevertheless, we cautioned Mr. Smith that he needs to take care of his fellow riders.

1 FILM REVIEW

Jockey MATT GARCIA met with the stewards this morning to discuss his ride in the ninth race yesterday in which he cuts it a little close when crossing in front of a rival turning for home. The stewards cautioned him that he needs to make a better effort to control his mounts and to maintain a straighter path.

Jockey ISAIAS ENRIQUEZ met with the stewards this morning to discuss his ride in the Eddie Read (G1) yesterday in which he guides his mount outwardly several paths in order to engage a rival to his outside. Although he was clear when he made the move, we made it clear that this type of race riding would not be tolerated.

Apprentice jockey MICHAEL MARTINEZ met with the stewards regarding his ride in the last race yesterday in which he has a difficult time controlling his mount leaving the gate. Mr. Martinez actually overcorrects his mount from drifting outward, causing the stewards to advise more subtle moves in the future.

Apprentice jockey JOSE CAMPOS met with the stewards regarding his ride in the fifth race yesterday in which he was partly the victim of an unlucky formation leaving the gate on the turf course. Nevertheless, the soon-to-be journeyman was told that he needs to be more cognizant of the horses to his inside.

Jockey VICTOR ESPINOSA met with the stewards regarding a race from Saturday leaving the gate. We felt that he could have made a better effort to keep his horse straight and he agreed.
