CANANI HEARING CASE #10HP060

The informal hearing involved a possible violation by trainer Julio Canani of rule 1865 (Altering of Sex of Horse). Mr. Canani testified that his practicing veterinarian, Dr. Joe Morgan castrated the horse "Sulution" at Hollywood Park on July 14, 2009 and reported this to the Receiving Barn. Mr. Canani felt this action relieved him of the responsibility of his foal papers being improperly registered in the racing office. Decision to follow.

FILM REVIEW

Apprentice jockey Jesus Velazquez joined the Stewards to review two races from yesterday (2nd & 4th). In both races he was advised by the Stewards to make better decisions which will help create safer riding. He stated he would be more aware in the future.

Jockey Osman Cedeno also met with the Stewards to review the second race in which he was involved in a reverse stair-step folding into the far turn. Mr. Cedeno was located on the fence with three horses to his outside, all staggered in front of him. He was advised in the future it would be safer to take back when unable to hold a safe position. Mr. Cedeno admitted he had made the wrong decision by not retreating earlier and stated it would not happen again.

Following the running of the race the inquiry sign was posted to review an incident approaching the 1/8 pole. The jockey of # 4 Irish Torrent who finished 3rd also lodged a claim of foul against # 7 Fashion Trend (2nd J. Talamo); also involved in the inquiry was # 1 Hello Walls (4th P. Atkinson). After a review of the videos, conversation with all the jockeys involved and the Patrol Judge it was a unanimous vote to let the original order of finish stand. Nearing the 1/8 pole # 1 drifted in making contact with # 4 causing the latter to take up, # 4 came back on to beat # 1 making the issue moot. The claim of foul was disallowed, # 7 was not involved in the incident.
