08-18-14¹ **DARK DAY**

08-19-14¹ **ENTRIES FOR FRIDAY**

Friday's program consists of one Mule, one Arabian and four Thoroughbred races for a total of six races. A total of 38 entrants are scheduled to start. No Cal-bred races were used.

08-19-14² **POST TIME CHANGE APPROVED**

Friday's post time will be moved back one hour from 2:07 p.m. to 3:07 p.m. Management requested the change to be more in sync with Del Mar's racing program. Executive Director Rick Baedeker approved the change.

08-20-14¹ **CHANGES AND SCRATCHES FOR FRIDAY**

One scratch to re-enter for Saturday and three jockey changes were made for Friday.

08-20-14² **ENTRIES FOR SATURDAY**

One Arabian, two Mule and six Thoroughbred races comprise Saturday's nine races. Fifty-nine entrants are scheduled to compete.

Thursday**08-21-14¹ CHANGES AND SCRATCHES FOR SATURDAY**

No jockey changes or scratches were activated for Saturday's card.

08-21-14² ENTRIES FOR SUNDAY

One Mule handicap, one Arabian stake and seven Thoroughbred races make up closing day's nine races. Included in the Thoroughbred races is the ever popular "C.J. Hindley-Humboldt County Marathon" at one mile and five eighths which drew a full field.

Friday**08-22-14¹ RULING NO. 1 – RODRIGUEZ (REF: 08-17-14²)**

Jockey **FREDDY RODRIGUEZ**, who was scheduled to ride **SAMMIES MOMENT** in the third race on August 17, 2014 at the Humboldt County Fair (Ferndale), is hereby fined one hundred dollars (\$100)* for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued when Rodriguez failed to contact the stewards by scratch time necessitating a late jockey change.

08-22-14² RULING NO. 2 – GUGLIELMINO (REF: 08-17-14²)

Jockey **KASSIE GUGLIELMINO**, who was scheduled to ride **MARY JEANENE** in the sixth race and **JASPER** in the eighth race on August 17, 2014 at the Humboldt County Fair (Ferndale), is hereby fined two hundred dollars (\$200)* for violation of California Horse Racing Board Rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued when Guglielmino opted to ride in a Quarter Horse trial at Emerald Downs in Auburn, Washington.

08-22-14³ SCRATCHES AND CHANGES FOR SUNDAY

One rider change and one also eligible scratch were the only changes made for Sunday.

08-22-14⁴ VELAZQUEZ WARNED

Jockey Jesus Velazquez was shown the start of last Sunday's fifth race in which he let his mount drift out slightly. Velazquez had hurt his knee in the gate (REF: 08-17-14⁶) which may have contributed to his lack of concentration. A warning was issued in this instance.

08-22-14⁵ RACE #1 – RIDERS OFF AFTER RACE – MULES

#2 WIDE AWAKE and #4 PLEASE BELIEVE ME bucked off their riders Francisco Maldonado and Joe Crispin respectively, while pulling up following this 220 yard Mule event. #5 BAR JF LOTTOTICKET propped and jockey David Essman was unseated as well after the race. All jockeys involved were cleared to ride and the Mules were captured unhurt. Accident reports attached.

08-22-14⁶ RACE #1 & #2 – NO SHOW WAGERING

Due to late scratches the first and second races were reduced to four wagering interests. In accordance with CHRB Rule #1954 show wagering was cancelled.

08-22-14⁷ RACE #3 – INQUIRY – NO CHANGE

The inquiry sign was posted to review an incident shortly after the start of this five furlong race. #3 CRAZY ABOUT HIM (David Essman) clips the heels of eventual winner #4 SENJEN (Marcial Ramirez) and finishes fourth. After review it was determined that #3 drifts out slightly onto the heels of #4 causing its own problem. No change.

08-22-14⁸ **RACE #4 – ACCIDENT – INQUIRY – NO CHANGE**
 The inquiry sign was posted when #1 CELZO'S BIRDIE (Tr. Humberto Loma) fell near the 3/16 pole unseating jockey Dionicio Navarro. After review it was determined that #1 fractured its left foreleg. #1 was humanely euthanized on the track and jockey Navarro was transported to the hospital in Fortuna. There was a fourteen minute delay for the fifth race while waiting for a backup ambulance to arrive. Accident report attached.

Second place finisher #2 SENORITA (Joe Crispin) lugs out nearing the finish as #1 SASSY JAZZY (Francisco Maldonado) was attempting to pass. #1 finished third beaten a nose for second after being taken off its path by #2. #2 was disqualified and placed third for interference. Jockey Crispin was held blameless.

08-24-14³ **RACE #5 – LATE SCRATCH**
