6/25/2019

(1) **DUTY STEWARD**

The fifth race in the book, maidens three and up for a \$12,500 claim, failed to attract an entry.

(3) COMPLAINT #19LA0131

The above complaint was set aside after Equine Sports Medicine notified the Stewards that the debt had been satisfied.

RULING # 159

JOCKEY EDUARDO NICASIO IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FOURTH OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD, EXCESSIVE), DURING THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 23, 2019.

The above ruling was issued after Jockey Eduardo Nicasio went a bit overboard with his crop during the running of the Ed Burke Million Futurity.

(1) RULING #160

RULING # 160

OWNER MAX GUERRERO, HAVING FAILED TO RESPOND TO CHARGES ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY- \$1,055.00 TO EQUINE SPORTS MEDICINE), IS SUSPENDED FOR VIOLATION OF

CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF OWNER MAX GUERRERO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), MR. GUERRERO IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after Mr. Guerrero was unable to reach an agreement both parties could sign onto.

(2) FILMS

Jockey Minor Arana was in to review the start of Sunday's third race. His mount broke out and although #5 Slightly was somewhat inconvenienced, he had broken slowly and the Stewards felt the outcome of the race was not compromised. A warning was issued.

(3) RULING #161

RULING # 161

TRAINER LEANDRO HERNANDEZ, WHO STARTED THE HORSE "MAN O WORK" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON MAY 12, 2019, IS FINED FIVE HUNDRED DOLLARS (\$500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER OR OWNER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843 (a, b & d)(MEDICATION, DRUGS, AND OTHER SUBSTANCES), #1843.1 (PROHIBITED DRUG SUBSTANCES), AND #1844.1 (AUTHORIZED MEDICATION-METHYLPREDNISOLONE).

After an informal hearing was conducted telephonically with trainer Hernandez, the foregoing ruling was issued. Mr. Hernandez accepted full responsibility for the Methylprednisolone positive.

(4) OBJECTION-NO CHANGE

Following the seventh race, Jockey Vinnie Bednar on #3 Eyell Be Back (4th) claimed foul on both #2 Rousing Freight (5th- J. Roman) and #4 Cattail Cove (2nd- C. Huerta). The reality of the incident was that Rousing Freight broke out pushing Eyell Be Back into Cattail Cove. The vote was unanimous to make no change as Eyell Be Back finished in front of Rousing Freight.

(5) LATE DECLARATIONS

OWNER ROY MOOREFIELD IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY- \$3,270.00 TO ERIC BERMAN).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF ROY MOOREFIELD ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE). ROY MOOREFIELD IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION. SUSPENSION TO COMMENCE ON JULY 1, 2019.

The foregoing ruling was issued after Mr. Moorefield failed to honor a verbal agreement entered into with trainer Eric Berman.

(2) RULING #163

RULING # 163

JOCKEY ALBERTO ZEPEDA IS FINED FIFTY DOLLARS (\$50.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON JUNE 29, 2019.

The above ruling was issued after Jockey Zepeda was guilty of violating Rule #1688 (b)(6).

(3) CLAIM VOIDED

The first race claim of "Twisted Rosie" by trainer Jesus Uranga was voided after the filly was put on the vet's list as unsound by Dr. Beck. She was returned to trainer Ryan Hanson.

(4) NO PROBLEMS

Sunday's card was run without incident which included accessing the main entrance which was void of any demonstrators.
