OWNER MARCIAL GARCIA, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON OCTOBER 6, 2018 TO ANSWER A COMPLAINT REGARDING CASE 18LA0212, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR). SUSPENSION TO COMMENCE ON OCTOBER 15, 2018.

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF MARCIAL GARCIA ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE). SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after owner Garcia failed to appear to discuss complaint #18LA0212

**RULING # 252**

PONY RIDER JOSE GUERRERO, HAVING NOW APPEARED BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE, IS RESTORED TO GOOD STANDING. RULING #246, ISSUED AT LOS ALAMITOS RACE COURSE ON OCTOBER 7, 2018, IS SET ASIDE.

The above ruling was issued after pony rider Jose Guerrero appeared to address complaint #18LA0215

**RULING # 253**

PONY RIDER JOSE GUERRERO IS FINED FIFTY DOLLARS (\$50.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (8) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE – TESTED POSITIVE FOR MARIJUANA).

Paul Atkinson replaced Ron Church in today's hearing due to the fact that Steward Church was working as the Safety Steward the day that Mr. Guerrero's tack room was searched and the marijuana was discovered. Mr. Guerrero admitted that he uses marijuana in the evening to help him rest. He also produced a marijuana card he had been issued due to some old injuries.

(5) RULINGS #254

**RULING #254**

GROOM CESAR HURTADO IS SUSPENDED FOR FIFTEEN (15) DAYS (OCTOBER 15, 2018 THROUGH OCTOBER 29, 2018) FOR FAILURE TO COMPLY WITH LOS ALAMITOS RULING #215 DATED SEPTEMBER 16, 2018.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF CESAR HURTADO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after Mr. Hurtado again tested positive for Methamphetamine and Amphetamine in addition to failing to comply with other provisions of Los Alamitos Ruling #215 dated September 16, 2018.

(6) SAFETY ISSUE

The fourth race was delayed by nine minutes due to heavy lightning strikes in the area.

(7) INQUIRY-NO CHANGE

Following the seventh race, the Stewards posted the inquiry to review an incident nearing the finish. #4 "Boxcar Willi" (7<sup>th</sup>-J. Ayala) and #5 "Higher Icon" (6<sup>th</sup>-R. Sanchez) both had to steady slightly when #2 "Power Thinker" (3<sup>rd</sup>-S. Ramirez Jr.) drifted in and #6 "Dash Michael Dash" (5<sup>th</sup>-R. Aceves) shifted out. The Stewards felt that both horses were being outrun at the time and that the outcome of the race was not affected.

**RULING # 255**

TRAINER ANGELA AQUINO WHO STARTED THE HORSE “PROPHETINPARADISE”, THE THIRD PLACE FINISHER IN THE SIXTH RACE AT SONOMA COUNTY FAIR ON AUGUST 10, 2018, IS FINED TWO THOUSAND FIVE HUNDRED DOLLARS (\$2500.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (A) (TRAINER OR OWNER TO INSURE CONDITION OF THE HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A & B)(MEDICATION, DRUGS AND OTHER SUBSTANCES), #1843.1 (B)(PROHIBITED DRUG SUBSTANCES-FLUMETHASONE(16.4 PG/ML)).

An informal hearing was conducted this afternoon resulting in the foregoing ruling. Ms. Aquino testified she had sent “ProphetinParadise” to Santa Rosa under the temporary care of trainer Marsha Stortz while she was running horses at the Humboldt County Fair. The bulk of her horses remained at Los Alamitos. The error appears to have occurred when groom Osori mistakenly presented “ProphetinParadise” for treatment thinking it was “Sure Proof”. This appears to be accurate as Dr. Boyer’s confidential reflects “Sure Proof” as the horse that he treated. As the trainer of record, however, Angela Aquino must be held responsible.

Other than a track that was minutely off, it was a flawless night of racing at Los Alamitos.

SUSPENSION TO COMMENCE ON OCTOBER 15, 2018.

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF JENNA KATZBERG ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE). SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after pony rider Jenna Katzberg failed to show up concerning a bad check at Los Alamitos.

(2) FILMS

Jockey Cruz Mendez was in to review last evening's sixth race. His mount broke in and made minimal contact with the horse to his inside. We all felt that he could have reacted a bit quicker, but were comfortable that a warning would suffice in this matter.

(3) GOOD RACING

It was another fine evening of racing at Los Alamitos. The Robert L. Boniface Los Alamitos Invitational Championship was contested without a flaw.
