Report of the Board of Stewards for the week of February 28, 2017 through March 5, 2017.

**TUESDAY**

02/28/2017

(1) **DUTY STEWARD**

Steward Ron Church was in for entries and all other non racing day duties, to spell Randy Winick who will be on minutes starting tomorrow for the remaining five days this week.

(2) **ENTRIES AND DRAW**

The entries were completed late today, approximately four p.m., with a program compiled of three Quarter Horse, Three Thoroughbred and two Quarter Horse Thoroughbred mixed races, for an eight race evening.

(3) **CAL-BRED REPORT**

The California Bred fifth race in the condition book, for maidens three and up claiming price \$8,000 at a distance of three hundred yards, failed to fill with two entries.

**WEDNESDAY**

03/01/2017

(1) **SCRATCHES**

At 9:00 a.m. promptly, scratches and changes were called for as usual, with four rider corrections and the report of a first time gelding.

(2) **ENTRIES AND DRAW**

It was another slow entry day as the eight race program wasn't completed and drawn until after 5:30 p.m. this afternoon. There are four thoroughbred, three Quarter Horse and One Quarter Horse Thoroughbred mixed races.

(3) **CAL-BRED REPORT**

The first race offered in the condition book for California Bred maiden three year olds, claiming price \$10,000 at a distance of 300 yards, attracted only one entry, and was called off.

**THURSDAY**

03/02/2017

(1) **SCRATCHES**

There were no scratches or changes at the 9:00 A.M. designated scratch time for Saturday evening's program.

(2) **ENTRIES AND DRAW**

The draw for Sunday's program was concluded late again, approximately 6:30 p.m., and only a seven race program could be produced. There are four Quarter Horse and three Thoroughbred races on tap.

**(3) CAL-BRED REPORT**

The California Bred fifth race in the condition book went open with seven. There were four Cal-Breds entered in the 300 yard maiden claiming affair for \$5,000.

**FRIDAY**

03/03/2017

**(1) SCRATCHES**

There were no scratches or changes called for at the 9:00 a.m. deadline for Sunday's races.

**(2) JAMACA AND GARCIA RULINGS (ref. 2/10/17 (3) + (4))**

Groom Bennett Jamaca and pony rider Sierra Garcia were in to see the stewards for the penalty phase of their drug complaint hearings held on February 10, 2017. The result of the stewards deliberations on this matter are reflected in the following rulings.

**RULING # 51**

PONY RIDER SIERRA GARCIA IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION FOR ONE YEAR FROM THE DATE OF THIS RULING FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (8) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE – TESTED POSITIVE FOR METHAMPHETAMINE AND MARIJUANA.

FURTHERMORE, SIERRA GARCIA SHALL SHOW PROOF OF A RECOVERY PROGRAM ACCEPTABLE TO THE STEWARDS AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

**RULING # 52**

GROOM BENNETT JAMACA IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION FOR ONE YEAR FROM THE DATE OF THIS RULING FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (8) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE – TESTED POSITIVE FOR METHAMPHETAMINE AND MARIJUANA.

FURTHERMORE, BENNETT JAMACA SHALL SHOW PROOF OF A RECOVERY PROGRAM ACCEPTABLE TO THE STEWARDS AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

**(3) ROMAN RULING**

The following ruling reflects over use of the whip by Jonathan Roman in the seventh race on Sunday, February 26, 2017. This is Romans first offense in the last sixty days.

**RULING # 53**

JOCKEY JONATHAN ROMAN IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND – FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD). DURING THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON FEBRUARY 26, 2017.

**(4) VIDEO REVIEW**

The following ruling was issued to trainer Matthew Fales for a positive test finding of “two” NSAIDS in the post race sample of “Country Icon” on 1/28/2017, at Los Alamitos Race Course. Neither medication was above the allowable level, however, it is against CHRB rules to have “two” of these anti-inflammatories in a horses system when racing. Trainer Fales offered that he may have given a dose of oral Bute too close to race time, two days prior, and then he decides to switch to Banamine as his NSAID of choice for pre-race medication one day out. Matthew accepted complete culpability and said he was sorry.

**RULING # 54**

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE), TRAINER MATTHEW FALES, WHO STARTED THE HORSE COUNTRY ICON IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JANUARY 28, 2017, IS FINED FIVE HUNDRED DOLLARS (\$500)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (MEDICATION, DRUGS AND OTHER SUBSTANCES), #1843.1 (PROHIBITED DRUG SUBSTANCES) AND #1844(c)(AUTHORIZED DRUG SUBSTANCES – MORE THAN ONE APPROVED NSAID – PHENYLBUTAZONE(0.79 UG/ML) AND FLUNIXIN (8.1 NG/ML)).

(5) VOIDED CLAIM – 5<sup>TH</sup> RACE

In tonight's fifth race, #2 "Let's Go Everybody" was reported to be unsound in the right foreleg post race in the test barn by Official Veterinarian Dr. Gary Beck. This horse was returned to Trainer Angela Aquino.

(1) SUAREZ RULING #55

The following ruling reflects a penalty given to jockey Guillermo Suarez for failing to fulfill his mount in the third race on Friday night. Mr. Suarez had his representative call in saying he had a personal issue.

**RULING # 55**

JOCKEY GUILLERMO SUAREZ IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON MARCH 3, 2017.

(2) BROCKELBANK RULING #56

The following ruling was issued to Trainer John Brocklebank for not taking care of his business as a trainer and making proper arrangements for pre-race "Lasix" administration to his horse "Renegade Run" on February 26, 2017 at Los Alamitos. Apparently, his practicing stable vet had not been given the information or Mr. Brocklebank himself did not give the proper instructions? Its unclear exactly where the fault lies.

**RULING # 56**

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION), TRAINER JOHN BROCKLEBANK IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR FAILURE TO HAVE THE HORSE RENEGADE RUN TREATED WITH LASIX, RESULTING IN A LATE DECLARATION FROM THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON FEBRUARY 26, 2017.

(3) VOIDED CLAIMS

There were three claims that necessitated voiding for unsoundness. They were all returned to the original connection's stable.

2<sup>nd</sup> Race - #3 "BULLISH ON STEVE" was returned to Trainer Jesus Avalos for being unsound as reported by Official Veterinarian Dr. Gary Beck.

5<sup>th</sup> Race – There were two claims voided in the fifth race. #3 "TRUST UR INTUITION" was unsound in the right foreleg and returned to Trainer Angela Aquino's stable and #5 "ADRIATIC SKYE" was unsound in the left foreleg and was returned to Trainer Humberto Loma. Both of these were diagnosed by Official Veterinarian Dr. Beck.

(1) INQUIRY – SEVENTH RACE – NO CHANGE

The stewards posted the inquiry light to review an incident at the gate. It appears that #4 "REMEMBERING FLORENCE" (C. Huerta – D.N.F.) stumbled in her two front legs just after coming out of the starting gate. A careful review was made shortly after the finish of the 350 yard Quarter Horse Race, and the stewards unanimously voted to make no change to the original order finish. It was determined that the horse was the cause of her own problem. Jockey Carlos Huerta fell rather roughly to the track surface and was quickly attended to by the track Paramedic and EMT's. Mr. Huerta was released on his own after showing no sign of any serious inquiry.
