(2) RULING#241

RULING # 241

JOCKEY G. JAIRO RANGEL IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON AUGUST 28, 2016.

The foregoing ruling was issued after the taped replay verified violation of rule #1688(b)(6).

(3) FILMS

Jockey Minor Arana reviewed Sunday's first race with the Stewards this afternoon. He allowed his mount to move into a precarious position, which in turn placed other horses in harms way. Again he was warned to be cognizant of where he is at.

(4) RULINGS #242 AND #243

RULING # 242

OWNER BRENDAN BAKIR (TACHYCARDIA STABLES) HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 2, 2016, TO ANSWER A COMPLAINT REGARDING CASE #16LA0264, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF BRENDAN BAKIR ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The preceding rulings were issued following the failure of the named individuals to respond to the complaints.

(5) STEWARDS REVIEW

The Stewards reviewed the start of the fourth race during which #5Jazzys Sugar Spoon, the favorite, was off slowly. The filly began to lift just as Starter Brinson dispatched the field eliminating any chance she may have had. Her problems were her own doing and no change was warranted.

JOCKEY TONY GUYMON IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 2, 2016.

RULING # 245

JOCKEY RUBEN LOZANO IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 2, 2016.

The above rulings were issued after both riders were again found to be in violation of Rule #1688(b)(6).

(2) STARTING GATE INCIDENT

The loading process for the second race was interrupted when #1 All Magic threw jockey Christian Aragon onto the tractor while being led into his stall. In a majority decision, Steward Ward voting to scratch the horse, All Magic was taken back to the paddock and a new rider was named. Aragon's condition is unknown however he returned to the jock's room. All Magic won the race.

JOCKEY JESUS AYALA IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-SECOND OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 3, 2016.

The foregoing ruling was issued after jockey Ayala violated rule #1688 (b)(6).

(1) STEWARDS REVIEW

The Stewards conducted a review of the fourth race to examine the break. #7 Dockweiler, the favorite, whipped his head at the start eliminating any chance he may have had. His problems were self inflicted therefore he was declared a starter.

(2) CLAIM VOIDED

The fifth race claim of Jack Mountain by trainer Santos Perez was voided after the gelding was

placed on the vets list by Dr. Beck. He was returned to trainer Valentin Zamudio.
