ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE #LA34534, TAKEN FROM THE HORSE "ELICITY" THE THIRD PLACE FINISHER IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON MAY 20,2016. TESTED POSITIVE FOR PROCAINE (CLASS III). IT IS ORDERED THAT "ELICITY" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$875.00) EARNED BY OWNER AUDIE WILLIAMS AND KAYE WILLIAMS. TRAINER JUAN ALEMAN AND JOCKEY EDUARDO NICASIO BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY AUGUST 21, 2016 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD).

Having notified both the owner and trainer, neither of whom chose to be present, the stewards went forward with the disqualification of "Elicity" and issued the foregoing ruling.

(4) BAUTISTA TESTED

Acting on two anonymous letters the board investigators tested jockey Alex Bautista this afternoon. The sample was positive for methamphetamine. A split will be sent to Quest Labs and Mr. Bautista will remain off his mounts at least until the results from the lab are back.

JOCKEY VINNIE BEDNAR IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-SECOND OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON JULY 23, 2016.
