(2) DUFF SHIDAKER STOPS IN

Trainer Duff Shidaker stopped in to discuss why he was turned down for an exercise license by us. At the time we felt it would be a conflict of interest if he was galloping horses for other trainers while training his own stable. It was also brought up what insurance would cover him should he get injured on somebody else's horse. We did, however tell him we would reconsider the merits of the situation and get back to him.

(3) STATE VET BECK AND JESSICA LIGHTHILL VISIT

Dr. Beck and his secretary Jessica were in to go over some issues at the receiving barn. A horse ran here that was on the vets list and was then removed by a person unknown. There seems to be a Los Alamitos Vet's List and then another list for other tracks. This appears to invite errors which occurred with the previously mentioned horse. We have had numerous problems in the receiving barn lately due to a turnover in personnel which appears is about to happen again. It is almost certain there will be more to come pertaining to this situation.

(4) CLAIM VOIDED

The first race claim of "There Fore You" by Angela Aquino was voided after she was put on the Vet's list for bleeding by Dr. Beck. She was returned to trainer Ricardo Guillen.

(1) OBJECTION – NO CHANGE

Following the fifth race Trainer Paul Jones lodged an objection against the winner First Prize Luke. Nearing the finish First Prize Luke was drifting out and somewhat impeded Catching Fire who finished second. After speaking to the riders involved and reviewing the film the stewards voted unanimously to make no change. Paul's horse was beaten three quarters of a length and the stewards didn't feel the incident cost him that much ground.

(1) RULING #173

RULING # 173

TRAINER FRANCIS MEZA IS FINED SIX HUNDRED DOLLARS (\$600.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR THREE LATE DECLARATIONS – NO INSURANCE) ON SATURDAY JULY 2, AND SUNDAY JULY 3, 2016.

The foregoing ruling was issued after Trainer Meza failed to renew her insurance in a timely manner necessitating three late declarations.

(2) INQUIRY DISQUALIFICATION

The stewards posted the inquiry following the fifth race to review the run into the turn. #6 Mi Agave 2nd – C. Aragon) dropped in approaching the turn pushing #2 Sterling Wager(3rd – O. Santos) into #1 CJ. Terror (4th – C. Charlton) who in turn brushed the fence and was forced to steady. After speaking to the riders involved and reviewing the films the stewards voted unanimously to disqualify Mi Agave. Original order 3-(6)-2-1-5 Official order 3-2-1-(6)-5.
