(2) COBB RULING

RULING #60

IN THE MATTER OF: CODY COBB

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER CODY COBB ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #22, DATED JANUARY 30, 2015, SUSPENDING MR. COBB FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND CODY COBB IS RESTORED TO GOOD STANDING.

The above ruling was issued when the Stewards were informed by Equine Sports Medicine that the debt was paid in full.

(3) RIVERA RULING

RULING #61

OWNER GILBERTO RIVERA, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON APRIL 10, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0064, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF GILBERTO RIVERA ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued when Mr. Rivera failed to abide by his agreement with Equine Sports Medicine.

(4) SECOND RACE – INQUIRY - DISQUALIFICATION

Following the second race, the Stewards posted the Inquiry to review an incident near the 1/16 pole which involved #5 "Royaltys Hope" (5th – Jockey C. Mendez), #6 "Corona Paola" (4th – Jockey S. Mendez), #7 "No Changes" (9th – Jockey C. Huerta), and #8 "Peaceful Separation" (clipped heels and unseated her rider). The incident started when #5 drifts out, which causes #6, who overreacts, to shift out and into #7 who causes #8 to clip heels and unseats her rider.

After speaking to the riders involved and a thorough review of the film, the vote was unanimous to disqualify both #5 and #6. The rider was transported to La Palma Hospital for observation.

(1) MENDEZ RULING

RULING #62

JOCKEY SANTIAGO MENDEZ WHO RODE "CORONA PAOLA" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, APRIL 10, 2015, IS SUSPENDED THREE (3) RACING DAYS (APRIL 18TH, 19TH AND 24TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FOURTH TO UNPLACED. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after Jockey Santiago Mendez was unable to convince the Stewards that his best effort had been made to straighten his mount resulting in his disqualification.

(2) INIGUEZ RULING

RULING #63

JOCKEY SALVADOR INIGUEZ WHO RODE "PLEASE EVERYONE" IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, APRIL 10, 2015, IS SUSPENDED THREE (3) RACING DAYS (APRIL 18TH, 19TH AND 24TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

Jockey Salvador Iniguez felt an adequate effort had been made to correct his mount's wayward path in the first race last evening. After reviewing the race, the Stewards failed to agree with that contention, and three days were meted out.

(3) EIGHTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the eighth race when #1 "Speights Girl" (Jockey E. Gomez) became fractious in the starting gate and injured herself. Declared on recommendation of Track Veterinarian Dr. C. Jenkins. Refund: \$14,276.00.

(1) SANTOS RULING

RULING #64

APPRENTICE JOCKEY OMAR HERRERA SANTOS IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SATURDAY, APRIL 11, 2015, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after Jockey Santos appeared before the Stewards to explain his failure to ride his mount in the first race on April 11, 2015. Jockey Santos offered the explanation that he had transportation problems.

(2) FIFTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the fifth race as #6 “Mr. Day Tripper” (Tr. R. Gomez) was off in front during the warm-up and was declared on recommendation of Track Veterinarian Dr. Jenkins. Refund: \$5,851.00.
