(2) SOTO RULING**RULING #92**

TRAINER ANTONIO SOTO WHO STARTED THE HORSE "SUDDEN QUEST" IN THE THIRD RACE ON MARCH 30, 2014, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND DOLLARS (\$1,000.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE), #1844 (c-2) (AUTHORIZED MEDICATION) AND #1843 (a,b&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES – FLUNIXIN IN EXCESS OF PERMITTED LEVEL (43.2 ng/ml) CLASS IV).

The foregoing ruling was issued following an informal hearing to address Case #14LA0091. Trainer Soto admitted having the vet inject the horse the day before race day but had no idea how the high reading occurred. This is Mr. Soto's second violation within a year.

(3) SOTO HEARING DELAYED

Trainer Soto appeared and requested a delay in his hearing so he can better prepare. Mr. Soto was granted a ten-day extension.

(4) FOURTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the fourth race when #3 "Dashin Dreams" (Tr. P. Jones) unseated his rider in the post parade and ran off. Declared by the Stewards. Refund: \$4,974.00.

(2) SECOND RACE – INQUIRY - DISQUALIFICATION

The Stewards immediately posted the Inquiry sign following the running of the second race to review an incident at the start. Involved were #8 "Stolen Speed" (4th – Jockey G. Suarez), #7 "JDF Choice" (3rd – Jockey R. Aceves), #6 "BF Outlandishversion" (6th – Jockey C. Huerta), and #5 "Sonoran Foose" (8th – Jockey S. Mendez).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #8 from fourth to eighth position. Replays show #8 veering in at the start, impeding #7, #6, and #5, costing the latter an opportunity of better placement.

(2) **FIRST RACE – INQUIRY - DISQUALIFICATION**

The Stewards posted the Inquiry sign following the running of the first race to evaluate an observed incident at the start involving #4 "Augsburg" (4th – Jockey G. Boag), #3 "Pretty Darn Quick" (5th – Jockey E. Gomez) and #2 "Captain Shawn D" (3rd – Jockey B. Boulanger). Films reflect #4 broke in sharply at the start, impeding #3 and #2, costing the latter two a chance of better placement. For that action, #4 was disqualified from fourth to fifth position.
