02/18/2014

(1) DUTY STEWARD

One scratch, one rider change and one equipment change completed Friday's program changes.

(2) CAL-BRED REPORT

The sixth race in the book, mares four and up for a \$12,500 claim, was off with one (1 CAL-BRED). The eighth race in the book, The Denim N Diamonds Handicap, went CAL-BRED with six. Sub #1 in the book, three year olds for a claiming price of \$10,000, was called off with no entries.

Two rider changes completed Saturday's program corrections.

(2) CAL-BRED REPORT

The second race in the book, maiden three year olds for a \$20,000 tag, was off with no entries. Sub #1 in the book, three year olds for a \$4,000 claim, also failed to attract an entry.

The \$112,000 Los Alamitos Maiden Stakes will be one of three Quarter Horse and five Thoroughbred races Sunday evening.

(2) AGUILAR RULINGRULING #29

IN THE MATTER OF: FRANCISCO AGUILAR

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER FRANCISCO AGUILAR ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #19, DATED FEBRUARY 7, 2014, SUSPENDING MR. AGUILAR FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND FRANCISCO AGUILAR IS RESTORED TO GOOD STANDING.

The above ruling was issued after receiving confirmation from Equine Sports Medicine that Mr. Aguilar's outstanding debt to them had been satisfied.

(3) FLORES RULINGRULING #30

TRAINER JOSE FLORES WHO STARTED THE HORSE "EASYIST" IN THE SIXTH RACE ON JANUARY 3, 2013, AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE), AND #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES – METHYLPREDNISOLONE - CLASS IV).

The foregoing ruling was issued following an informal hearing to address case #14LA0011. Trainer Flores admitted having the vet inject the horse but testified he has never varied from his routine and until this incident has never had a problem. He stated he will reevaluate his routine.

(4) PURSE REDISTRIBUTIONRULING #31

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# LA25087, TAKEN FROM THE HORSE "VIBRANT," THE FIRST PLACE FINISHER IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JANUARY 5, 2014, TESTED POSITIVE FOR ZILPATEROL (CLASS III). IT IS ORDERED THAT "VIBRANT" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$2,640.00) EARNED BY OWNER LA BOTELLA RACING STABLE, TRAINER GERARDO AMEZCUA AND JOCKEY RAUL VALENZUELA BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY MARCH 23, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

The foregoing ruling was issued after the post race urine sample of "Vibrant" confirmed the presence of the class III prohibited drug zilpaterol.

(5) WARNING ISSUED

Following an informal hearing to address case #14LA0017, a warning was issued to Roberto Dominguez in accordance with California Horse Racing Board Rule #1844 (c)(1).

(6) FILMS

Jockey Roberto Hernandez reviewed Sunday's seventh race with the Stewards this afternoon. His mount broke in at the start, and he did a commendable job correcting him. However, further down track, the gelding ducked in again and his effort was rather lacking. He was warned that in the future a better effort would be expected of him.

(7) FILMS

Jockey Ramon Sanchez was in to review Sunday's second race. The Stewards all felt he could have made a better effort to straighten his mount but felt it fell short of warranting a suspension.

(8) CLAIM VOIDED

The fifth race claim of "No Mistress" by Trainer Bret Vickery was voided after being advised by Dr. Beck he was placing the horse on the Vet's List. The horse was returned to Trainer Gerardo Amezcua's barn.

OWNER DIANE M. RULING #34

OWNER JULIO ENCINAS, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 22, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0023, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JULIO ENCINAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing rulings were issued after the individuals named failed to appear to answer the alleged charges listed in the complaints.

(1) SUAREZ VISITS

Jockey Guillermo Suarez came in to review a film and explain his apparent disregard for the Stewards' authority. The first day he was asked to come in and review a film with the Stewards, he did not show up at all. The second day, he sent in a representative but failed to notify the Stewards. The third day, with the threat that he would not be allowed to name on horses, he showed up. We have had trouble with him in the past, and it was the same weak excuses, such as traffic. He was warned that if there was another incident, sanctions would be meted out.

(2) SEVENTH RACE - INCIDENT

Jockey Raul Valenzuela was questioned as to why he stood up on his mount approaching the finish in the seventh race. The horse was definitely in contention. He explained that his mount took a bad step, and he feared he may have been breaking down. The Stewards had State Veterinarian Dr. Beck examine the horse, and he found a rather bad laceration on the horse's right leg, which is consistent with a horse hitting and supported Valenzuela's opinion that the horse was in distress. With that evaluation, the Stewards felt Raul Valenzuela acted appropriately.

Sunday was another incident-free evening with nothing of significance to report.
