(2) JONES SECURITY VIOLATION

Trainer Paul Jones appeared before the Stewards to address his verbal altercation with the Stable Gate guard for which was cited. The heart of the dispute centered on the lack of parking spaces for trainers and owners near the main Stable Gate. Mr. Jones was asked by the Stable Gate guard to move his vehicle, which he refused to do. In his defense, Mr. Jones stated that the parking situation is continually changing, and it makes him angry. Mr. Jones was told the Captain of Security, Keith Hicks, would be consulted, and a decision would be forthcoming.

OWNER FRANCISCO AGUILAR, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 7, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0016, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF FRANCISCO AGUILAR ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Francisco Aguilar failed to appear to answer financial complaints alleging money owed to Equine Sports Medicine.

(4) AVECHUCO RULING

RULING #20

OWNER EDGAR AVECHUCO, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 7, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0014, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF EDGAR AVECHUCO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Edgar Avechuco failed to appear to answer

financial complaints alleging money owed to Equine Sports Medicine.

(5) SEVENTH RACE – VOIDED CLAIM

Trainer Jesse Godinez's seventh race \$16,000 claim on #2 "Annas Man 2" was voided by the Stewards after Owner Erma Zamudio, wife of suspended Trainer Valentin Zamudio, was found ineligible to place a claim per violation of California Horse Racing Board Rule #1420 (n) (Spousal Joint Ownership). "Annas Man 2" was returned to Trainer John Cooper's barn.

IT IS ORDERED THAT "DASHERS JESSIE" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$2,970.00) EARNED BY OWNER GEORGE T. AND JUDY WELDON, TRAINER RYAN HANSON AND JOCKEY CESAR DE ALBA BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY MARCH 10, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

IT IS ORDERED THAT "TR SPECIALTY" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$2,585.00) EARNED BY OWNER JOSE R. OLIVAS, TRAINER GUILLERMO MORALES AND JOCKEY SANTIAGO MENDEZ BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY MARCH 10, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

(1) JONES RULING**RULING #23**

TRAINER PAUL C. JONES IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – DISOBEDIENCE TO STABLE GATE GUARD).

The above ruling was issued after discussing the citation issued to Trainer Paul Jones with Keith Hicks, Captain of Security at Los Alamitos Race Course. At issue was the verbal abuse, foul language, and disrespect towards Security personnel and racing officials that was vocalized.

(2) NOLAN RULING**RULING #24**

OWNER STEVE W. NOLAN, HAVING FAILED TO ABIDE BY A FINANCIAL AGREEMENT WITH EQUINE SPORTS MEDICINE IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY)

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF STEVE W. NOLAN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued due to Mr. Nolan's failure to contact or appear before the Stewards concerning his past due financial obligations.

(3) THIRD RACE – JOCKEY OBJECTION – NO CHANGE

After the running of the third race (Thoroughbred – 4½ furlongs), Jockey Dee Dee Williams, who rode #6 “Distinctive Dude,” the third place finisher, lodged a complaint against #2 “Forest Prince” (2nd – D. Navarro) for alleged interference after the 1/16th pole. Film review failed to show any compromise to the order of finish. The Stewards unanimously agreed to make no change.

(4) FOURTH RACE – INQUIRY – NO CHANGE

Following the finish of the fourth race (Quarter Horse – 330 yards), the Stewards posted the Inquiry to review the start. Replays verify #2 “RGR Down N Dirty” (7th – R. Valenzuela) whipped his head to the left, pinning himself in the gate. As the gate opened properly, “RGR Down N Dirty” was responsible for his own problems and declared a starter.
