RUBIO, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 8, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0236, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF OSCAR R. RUBIO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #154

OWNER SALVADOR VELIZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 8, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0243, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF SALVADOR VELIZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #155

OWNER JOSE RIGO OLIVAS, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 8, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0242, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE RIGO OLIVAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above rulings were issued after the individuals named failed to appear to address the alleged charges listed in the complaints.

(1) GALVAN RULINGRULING #156

OWNER/GROOM LUIS GALVAN IS FINED TWENTY-FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – SPEEDING IN BARN AREA).

The above ruling was issued after Groom Luis Galvan met with the Stewards and had no excuse for speeding in the barn area.

(1) SOTO RULINGRULING #157

TRAINER ANTONIO R. SOTO WHO STARTED THE HORSE “DEAR CREEK” IN THE THIRD RACE ON OCTOBER 5, 2013, AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE) AND #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES – GUAIFENESIN AND DEXTORPHAN, A METABOLITE OF DEXTROMETHORPHAN).

The foregoing ruling was issued following an informal hearing with Trainer Tony Soto. Tony explained that the horse's owner mistakenly gave the solution, but as trainer, he accepted full responsibility for the situation.

(3) PURSE REDISTRIBUTIONRULING #158

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# LA24326, TAKEN FROM THE HORSE “ZOOMDASHER”, THE SECOND PLACE FINISHER IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 29, 2013, TESTED POSITIVE FOR CLENBUTEROL (CLASS III). IT IS ORDERED THAT “ZOOMDASHER” BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$25,500.00) EARNED BY OWNERS GUSTAVO AND JOSE DE LA TORRE, TRAINER JOSE DE LA TORRE AND JOCKEY CARLOS M. HUERTA BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY DECEMBER 9, 2013 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

An informal hearing was convened this afternoon concerning case #13LA0231, the disqualification of the horse "Zoomdasher." Trainer Jose De La Torre attended the proceedings. The outcome of that hearing is reflected in the above ruling.

The Stewards posted the Inquiry following the fourth race to review an incident mid-stretch. #4 "Kiddychan" (3rd – F. Rubio) drifted in, putting #3 "Lavish John D" (8th – R. Valenzuela) on his heels and denying him any opportunity at a decent placing. After polling the involved riders and examining the films, the Stewards in a unanimous vote disqualified "Kiddychan."
