(1) EARLY PROGRAM SCRATCHES

1st Race - # 6 Full On (Tr. A. Soto) entered back, Stewards.

3rd Race - # 6 Truco Latino (Tr. C. Treece) entered back, Stewards.

6th Race - # 1 Electra Czech (Tr. S. Fiscal) sick, Dr. Hackathorn.

(2) WARREN RULINGRULING #115

OWNER CLARK WARREN, HAVING FAILED TO ABIDE BY A FINANCIAL AGREEMENT WITH EQUINE SPORTS MEDICINE IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF CLARK WARREN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after Mr. Warren failed to abide by his financial agreement to Equine Sports Medicine.

(3) FIFTH RACE – RIDER REPLACED

Prior to the start of the fifth race, #6 "So Pretty" (Tr. C. Treece – jockey D. Torres) reared up before the start, injuring jockey Torres who was taken to Los Alamitos Hospital for x-rays. Jockey Torres was replaced by Leonardo Gonzalez, whose mount finished second.

(4) FIFTH RACE – JOCKEY OBJECTION – NO CHANGE

Following the running of the fifth race, jockey Dionicio Navarro who rode #2 "Moonlite Classic," who finished third, lodged a claim of foul against #6 "So Pretty" (jockey L. Gonzalez– 2nd) for alleged interference near the finish. After a review of the film and talking with the riders involved, it was a unanimous decision to let the original order of finish stand due to the fact the films did not verify the claim of foul.

(2) WHITAKER RULINGRULING #116

OWNER MARK WHITAKER, HAVING FAILED TO APPEAR BEFORE THE BOARD OF

STEWARDS AT LOS ALAMITOS RACE COURSE ON AUGUST 9, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0172, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF MARK WHITAKER ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after owner Mark Whitaker failed to address his alleged debt to Equine Sports Medicine in the amount of \$380.

This evening's racing program was conducted without noteworthy incident.

(1) SECOND RACE - LATE DECLARATION - REFUND

A refund was ordered in the second race when #6 "Royal N Wicked" (Tr. L. Melton – jockey F. C. Rubio) became rank during the loading procedure, unseated her rider and ran off. Declared by the Stewards. No injury to rider or horse. Refund: \$8,886.00.

(2) FOURTH RACE – DOUBLE REFUND - DECLARATIONS

Two refunds were ordered in the fourth race when the riders of both #2 "Sure Fire First" (jockey C. Mendez – Tr. J. Moreno) and #6 "I Lead U Follow" (jockey R. Aceves – Tr. J. Flores) felt their mounts were off. Track Veterinarian Dr. Tom Hackathorn could find nothing wrong with either horse, which was confirmed by State Veterinarian Dr. Gary Beck. Both horses were declared by the Stewards. Refunds: \$11,093.00 (#2); \$14,081.00 (#6).

Due to the two scratches, which reduced the field to four entries, there was no show wagering.

(3) CLAIM VOID

The fifth race claim of "Awise Secret" by Trainer Valentin Zamudio was voided after State Veterinarian Dr. Gary Beck declared the filly unsound and placed her on the Vet's List. The filly was returned to Trainer Jose Moreno.
