(2) GONZALEZ RULING

IN THE MATTER OF: RULING #75  
MARLYN & BERENISSE GONZALEZ

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNERS MARLYN & BERENISSE GONZALEZ ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #74, DATED MAY 11, 2013, SUSPENDING MARLYN & BERENISSE GONZALEZ FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE AND MARLYN & BERENISSE GONZALEZ ARE RESTORED TO GOOD STANDING.

This ruling was issued after Equine Sports Medicine notified the Stewards that Marlyn and Berenisse Gonzalez's outstanding debt had been resolved.

(3) RULINGS #76-77

RULING #76  
GROOM BYRON A. ORANTES IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION THROUGH DECEMBER 31, 2013 FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT - UNDER THE INFLUENCE OF ALCOHOL AND FIGHTING).

RULING #77  
GROOM HUMBERTO M. PEREZ IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION THROUGH DECEMBER 31, 2013 FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT - UNDER THE INFLUENCE OF ALCOHOL AND FIGHTING).

The above two rulings were issued after both subjects appeared before the Stewards as requested. Both admitted to participating in an altercation in the trainer's parking lot. Both vowed the incident would not happen again.

(4) FOURTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the fourth race when #1 "Eyema Blue Dasher" (Trainer J. Bassett) became fractious in the starting gate and injured herself. Declared by the Stewards on recommendation of Track Veterinarian Dr. Tom Hackathorn. Refund: \$4,639.00.

(5) NINTH RACE – LATE DECLARATION - REFUND

A refund was ordered when #4 "Campaign Cash" (Tr. J. Gomez) broke through the starting gate doors, unseated the rider and ran off. No injury to rider or horse. Refund: \$18,421.00.

(1) MARTINEZ RULING

RULING #78

TRAINER SILVERIO G. MARTINEZ WHO STARTED THE HORSE "RAY'S STORM" IN THE FOURTH RACE ON APRIL 5, 2013, AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE), #1844 (c-1) (AUTHORIZED MEDICATION) AND #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES – PHENYLBUTAZONE EXCESS OF PERMITTED LEVEL (3.9 UG/ML) CLASS IV).

The foregoing ruling was given after Mr. Martinez was given an informal hearing concerning his high bute reading. He could only surmise that his groom inadvertently fed the bute late. Martinez was cautioned to handle his feeding program in a more adequate manner.

(2) FIRST RACE DELAY

An eight-minute delay occurred in the first race when #4 "Lucky To You" (Tr. G. Morales – jockey D. Navarro) injured the rider while awaiting the start. The horse was returned to the Paddock for a new rider.

The Stewards had the Inquiry sign posted following the running of the ninth race (Quarter Horse – 300 yards – Kindergarten Futurity – Purse: \$281,100.00) to review an incident near the 1/16 pole. Involved were #6 "Shake Djibouti" (9<sup>th</sup> – jockey G. Arriaga) and #8 "Shaded Secrets" (jockey C. De Alba).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #8 from eighth to ninth position. Replays reflect #8 veers in, bumping #6 off stride and costing #6 an opportunity of better placement. #6 was beaten by a head.
