(2) RIDER OFF

Pursuant to California Horse Racing Board Rule #1500.01, jockey Dionicio Navarro was removed from his mounts this evening due to being unable to produce a urine test sample. Jockey Navarro is currently under a testing agreement with the California Horse Racing Board. In accordance with California Horse Racing Board Rule #1886, Mr. Navarro cannot exercise horses until producing a negative sample.

(3) SECOND RACE – INQUIRY – ACCIDENT – NO CHANGE

Following the running of the second race the Stewards posted the Inquiry sign to evaluate two separate incidents at the start. In the first, #1 “Lucky And Tough” (jockey G. Gavica) reared up simultaneously to the start, causing the rider to lose his balance and be unseated.

In the next incident, #5 “Brother Ernie” (jockey V. Bednar) stumbled severely at the start, nearly unseating the rider. In both incidents, neither the riders or horses were injured.

(4) THIRD RACE – LATE DECLARATION - REFUND

A refund was ordered in the third race when Horse Identifier Juan Garcia informed the Stewards that #1 “Awesome Courage” (Tr. K. Craigmyle) lost a shoe in the Receiving Barn and could not be repaired due to the horse being fractious. Declared by the Stewards. Refund: \$1,376.00.

(5) EIGHTH RACE – INQUIRY – NO CHANGE

Following the running of the eighth race, the Stewards posted the Inquiry sign to evaluate an incident at the start, which involved #3 “IVR Princess” (Tr. G. Morales – jockey S. Mendez). After speaking with Starter John Baker, jockey Mendez and reviewing the tapes, the Stewards opted to make the race official. Tapes reflect that #3 appears to sit down simultaneously to the doors opening. At the same time, the rider steps off. Neither rider or nor horse was injured.

(6) NINTH RACE – LATE DECLARATION – REFUND

A refund was ordered in the ninth race when #1 “Bok The Great” (Tr. L. Ruiz – jockey G. Arriaga) was declared by the Stewards. Rider refused to ride his mount. Refund: \$9,423.00.
