OWNER ANGELICA PEREZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 1, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0028, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF ANGELICA PEREZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Ms. Perez failed to appear to address a financial complaint alleging she owes Equine Sports Medicine \$357.00.

(3) RULINGS #23-24RULING #23

OWNER BARBARA J. SNELLMAN, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 1, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0029, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF BARBARA J. SNELLMAN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #24

OWNER DENNIS SNELLMAN, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON FEBRUARY 1, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0029, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF DENNIS SNELLMAN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing rulings were issued after both subjects failed to appear to address charges of alleged violation of California Horse Racing Board Rule #1876 (Financial Responsibility).

(4) MACIAS RULING

RULING #25

JOCKEY OSVALDO MACIAS, HAVING NOW APPEARED TO ADDRESS CALIFORNIA HORSE RACING BOARD COMPLAINTS #12LA0284 AND #12LA0285 IS RESTORED TO GOOD STANDING AND LOS ALAMITOS RACE COURSE RULING #199, DATED DECEMBER 23, 2012, SUSPENDING MR. MACIAS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR), IS SET ASIDE.

The above ruling was issued after jockey Osvaldo Macias appeared before the Stewards to address complaints #12LA0284 and #12LA0285 for alleged violation of California Horse Racing Board Rule #1489 (Grounds for Denial or Refusal of License), #1890 (Possession of Contraband) and #1902 (Conduct Detrimental to Horse Racing).

(5) FARRIS HEARING

A formal hearing was held to address case #12LA0281. Present were trainer Vod Farris, Alexis Svenson, Investigator Tom Blake and the Board of Stewards. The proceedings were recorded by Barbara Weinstein. At issue was the contraband found in his groom's tack room. Both grooms were suspended for the paraphernalia, which was confiscated. Farris denied any knowledge of the items found in the employee's room. Ruling forthcoming.

(6) MACIAS HEARING

A formal hearing was held to address case #12LA0284 and case #12LA0285. Present were jockey Osvaldo Macias, his interpreter Daniel Torres, Jockey's Guild Representative Darrell Haire, Security Guard Jorge Abina, California Horse Racing Board Investigator Tom Blake, witness Juan C. Pasion, the Board of Stewards and Court Reporter Barbara Weinstein.

Jockey Macias was suspended for failure to appear back on December 22, 2012 on two complaints: one for testing positive for marijuana and the other for having an electrical device in his tack room.

Witness Juan C. Pasion, who was suspended earlier in the year, testified that he found the machine and left it in the tack room. Due to time constraints the hearing will be continued Friday, February 8, 2013.

(7) FIRST RACE – LATE DECLARATION - REFUND

A refund was ordered in the first race when jockey Luis Medina refused to ride #3 "Ale's Emerald" (Tr. K. Castaneda). Declared by the Stewards. Refund: \$9,586.00.
