Report of the Board of Stewards for the week of June 5, 2012 through June 10, 2012.

TUESDAY

06/05/2012

(1) **DUTY STEWARD**

Albert Christiansen will be present for morning responsibilities and shall create the minutes for the week.

(2) **CAL-BRED REPORT**

Two races were offered CAL-BRED, neither of which filled. The fifth race in the book for maidens, three and four years old, claiming price \$4,000, going 300 yards, had three entries. Sub race #3 for three year olds, claiming price \$12,500, going 330 yards, had only one entry.

(3) **THE DRAW**

Nine races were drawn for Friday's program. Three Thoroughbred and six Quarter Horse races finalized the card.

WEDNESDAY

(1) **SCRATCHES**

Three equipment changes and one rider change completed scratch time at 9:00 a.m.

(2) **CAL-BRED REPORT**

The "Ivan Ashment Handicap" for CAL-BRED fillies and mares three years old and upward was carded with six entries.

There was not a CAL-BRED race due to the entire card of trials for the "Ed Burke Million Futurity."

Thirteen races were drawn for Sunday's program. All races are trials for the "Ed Burke Million Futurity." One hundred and ten two year old Quarter Horses entered the trials.

(1) SCRATCHES

Two rider changes completed scratch time at 9:00 a.m.

(2) INFORMAL HEARING

Trainer Kelly Castaneda appeared to address a bute overage (2.71 ug/mL – allowable level is 2.0 ug/mL). The trainer stated he administers all the bute himself 24 hours before the race. He stated that the bute application program will be adjusted. An official warning was issued as this was the trainer's first violation ever.

(3) STABLE ACCIDENT

Groom Angel Galvan Venegas, working for trainer Joe Bassett, was kicked in the head by the two year old "Track A Tac" as they were headed to the Receiving Barn for the ninth race. The horse had a surcingle and saddle pad that slipped as the groom was leading the horse, causing the horse to buck, resulting in the unfortunate groom being kicked. At this time it is reported that Mr. Venegas is on life support. The horse was scratched when he ran loose in the barn area.

(1) INFORMAL HEARING

An informal hearing was agreed upon to address California Horse Racing Board Case #12LA0107. The complaint alleged violation of excesses of butazolidin and Flunixin against trainer Lissette Hernandez. The trainer stated her father treated the horse with banamine paste and she treated him with bute. The case involved two Class C penalties and one class D penalty, resulting in the following ruling.

(2) HERNANDEZ RULINGRULING #78

TRAINER LISSETTE HERNANDEZ WHO STARTED THE HORSE "AJS KISSNTELL" IN THE EIGHTH RACE ON APRIL 28, 2012, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND DOLLARS (\$1,000.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1844 (C)(1-2) (AUTHORIZED MEDICATION) PHENYLBUTAZONE AND FLUNIXIN (CLASS IV).

This ruling was issued after the above informal hearing.

(3) BAUTISTA RULINGRULING #79

JOCKEY ALEX BAUTISTA IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON FRIDAY, JUNE 8, 2012, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

This ruling was issued as Mr. Bautista traveled to Ruidoso after being named on horses here Friday.

(4) NO PROBLEMS

Nine races were completed without a reportable incident.
